

M/WBE Summary

Public notice was given for this solicitation, CLMC615 Gonzales Lift Station Abandonment Project, through the City's Vendor Connection web portal which resulted in 156 contractors receiving notification and 84 contractors obtaining the bid documents. Five bids were received and opened on November 10, 2016. Four of five bids received were certified MBE/WBE firms. M.A. Smith Contracting Inc. submitted the lowest responsive bid:
