

ORDINANCE NO. _____

AN ORDINANCE ANNEXING, FOR FULL PURPOSES, ADDITIONAL TERRITORY ADJACENT TO THE CITY LIMITS OF THE CITY OF AUSTIN REFERRED TO AS THE “ENTRADA” ANNEXATION AREA, CONSISTING OF APPROXIMATELY 246 ACRES OF LAND IN NORTHEASTERN TRAVIS COUNTY, TEXAS; AND APROOVING A SERVICE PLAN.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The Council finds that:

- (A) Notice of the two public hearings concerning annexation of the territory described in Exhibit A was published in a newspaper of general circulation in the City of Austin and in the area to be annexed, and on the City of Austin website.
- (B) The public hearings were held on October 6, 2016 and October 13, 2016, at the Austin City Hall, 301 West 2nd Street, Austin, Texas.
- (C) The public hearings were concluded after providing an opportunity for all persons present to be heard with respect to the proposed annexation. A proposed Service Plan was made available and explained at the public hearings required by law.
- (D) The annexation, for full purposes, of the territory described in Exhibit A serves the interest of the current and future residents of the City of Austin.
- (E) All procedural requirements imposed by state law for the full purpose annexation of the territory described in Exhibit A have been met.
- (F) The annexation of the territory described in Exhibit A will result in an unincorporated area that is surrounded by the full purpose territory of the City. In accordance with Texas Local Government Code Section 43.057, the Council finds that surrounding that unincorporated area is in the public interest.

PART 2. The present boundary limits of the City are amended to include the following territory which is within the extraterritorial jurisdiction and adjacent to the city limits of the City of Austin in Travis County, Texas and which is annexed into the City for full purposes:

2 Approximately 246 acres located in northeastern Travis County, south of Wells
3 Branch Parkway at the intersection of Immanuel Road and Crystal Bend Drive, this
4 area is more particularly described in Exhibit A.

6 **PART 3.** The Service Plan attached as Exhibit B is approved as the Service Plan for
7 the area.

9 **PART 4.** The City Council declares that its purpose is to annex to the City of Austin
10 each part of the area described in Exhibit A as provided in this ordinance, whether any
11 other part of the described area is effectively annexed to the City. If this ordinance is
12 held invalid as to part of the area annexed to the City of Austin, the invalidity does not
13 affect the effectiveness of this ordinance as to the remainder of the area.

15 If any area or lands included within the description of the area set out in Exhibit A are:
16 (1) presently part of and included within the general limits of the City of Austin; (2)
17 presently part of and included within the limits of any other city, town or village; or (3)
18 are not within the jurisdiction of the City of Austin to annex, then that area is excluded
19 and excepted from the area annexed.
