This letter documents unprofessional, disrespectful, discourteous, ass-backwards, bullying behavior against me by public servant Hispanic Male Library staff member John.

Specifically, I first tried logging onto + using the second library computer from the left, The 60-minute station adjacent to the 15-minute computer station. However, that computer's on-screen arrow was not functioning - it was frozen.

So, I checked at the underside of the computer mouse + I could see the red laser light on underneath + that the mouse could be rolled/moved, so that hardware seemed OK.

So, next I checked the mouse's connection to the back of the computer drive hardware. The connection seemed good. So, I played with the wire connecting the mouse to the computer hardware, but that, too, did NOT unfreeze the on-screen arrow.

So, I unplugged + re-plugged in the

60-minute computer to non-verbally signal a problem there that needed to be fixed.

Then, I logged on to the 15-minute workstation & started silently using the computer.

About 2-3 minutes later, public servant library staff member John walked by, saw the adjacent 60-minute computer's mouse unplugged & asked me in a disrespectful tone if I had unplugged it, like he was trying to blame me for something, though I'd done nothing wrong.

So I did not answer his disrespectful, accusatory question, but responded respectfully, telling him that 60-minute computer workstation was not working. However, instead of thanking me for helping him or respectfully asking me what the problem was, John again disrespectfully treated me like a child, immediately telling me not to touch the computer equipment on the back of the hardware, as if the computer was his private property, when the truth is it's public property paid for by public tax dollars for public use, attended to by public servants, like John.

Worse, John's demeaning demeanor clearly implied his unfounded fear that by touching the equipment, I might damage →
