CALL TO ORDER: The meeting was called to order at 6:05 pm by BAC Chair Tom Thayer.

- Doug Boyer: presented concerns related to the Pedernales two-way protected bike lane. He stated that he and his family use this facility daily and appreciate the new infrastructure. He suggested several improvements to limit bicycle-vehicle interactions and asked the BAC to consider adding a future agenda item for further discussion.

- 4. Items from Community:
  - A. Connections 2025 Draft Plan Discussion and Possible Action

Caitlin D'Alton of Capital Metropolitan Transportation Authority gave a presentation, which included What We've Heard, Plan Design Principles, Service Options – Mobility Toolbox, Proposed Plan, Rapid Transit, MetroRapid, Frequent Local, Frequent Network, Local, Express, Community, UT Shuttle, Mobility Hubs, Frequent Network Benefits, Ridership Impacts, ADA Impacts, Cost Implications of Proposed Plan, Plan Summary, Community Outreach Strategy, and Next Steps.

No action taken.

B. I-35 through Downtown (Riverside Drive to MLK Boulevard) section of Central 7-mile Comprehensive Project – Discussion and Possible Action

BAC Vice Chair Sophia Benner presented draft recommendation language which, after debate and amendment, stated "BE IT RESOLVED, that the BAC supports the IH-35 Cut and Cap plan."

**Action taken**: A motion to approve the recommendation as amended passed unanimously on Sophia Benner's motion and Mike Sledge's second. ## 5. Items from BAC:

# A. Roy G. Guerrero Park Trail - Discussion and Possible Action

Malcom Yeatts shared updates on his effort to apply for grants for projects that would improve cycling connections at Roy G. Guerrero Park during the interim time before the structurally destroyed bridge over the actively eroding channel is replaced there, as well as his conversations with a local disc golf association concerning disc golf player and cyclist safety in the park.

Malcom Yeatts then presented draft recommendation language which, after debate and amendment, stated "BE IT RESOLVED, that the BAC requests that the Parks and Recreation, Public Works, and Watershed Protection departments and the Active Transportation division of the Austin Transportation Department convene a meeting of stakeholders to choose a temporary alternative route for crossing Country Club Creek for pedestrians, bike riders, and disc golf players until the new bridge is completed."
