Chapter 252 of the Local Government Code requires that municipalities comply with the procedures established for competitive sealed bids or proposals before entering into a contract requiring an expenditure of \$50,000 or more, unless the expenditure falls within an exemption listed in Section 252.022.

Senate Bill 7 amended Chapter 252 of the Local Government Code to exempt from the requirements of such Chapter expenditures made by a municipally owned electric utility for any purchases made by the municipally owned electric utility in accordance with procurement procedures adopted by a resolution of its governing body that sets out the public purpose to be achieved by those procedures. The Austin City Council has adopted Resolution No. 040610-02 to establish circumstances which could give rise to a finding of critical business need for Austin Energy.

This Certification of Exemption is executed and filed with the Purchasing Office as follows:

The agenda management software (SIRE) is managed by Hyland Software. This software is crucial to the legislative process for the City of Austin and is used on a daily basis. The contract is slated to expire in November of 2015. An RFI was submitted earlier in 2015 to identify possible vendors in the agenda management field. However, the department has yet to formalize an RFP. Extending the contract will allow the City to continue managing the legislative process and allow staff time to complete an RFP. The current software is meeting the City's needs as it performs services to support the new council geographic representation model.

Currently, the software meets the current and changing needs of the City as it manages a new form of council government (geographic representation). There are currently over 220 users throughout the City that utilize this system on a day-to-day basis. Application of similar software from other vendors would require training of City users and staff. Historically, the training process has lasted anywhere between 4-8 months and would extremely disruptive to the current legislative process. The legislative process is an intricate process that requires knowledgeable users to supply comprehensive council agenda related agenda items in a timely manner.
