

ORDINANCE NO. 20170302-008

AN ORDINANCE AMENDING EXHIBIT A TO ORDINANCE NO. 20160914-003 TO REVISE THE FISCAL YEAR 2016-2017 DEVELOPMENT SERVICES DEPARTMENT FEE SCHEDULE TO CHANGE THE FEES FOR EXPEDITED PLAN REVIEW.


