Additional Backup Information

The Aviation Department requests approval, in accordance with Federal Treasury Regulations, of an Official Declaration of Intent to Reimburse construction and other related costs of improvements to Austin-Bergstrom International Airport (ABIA) Improvements.

For the City to spend money today, but reimburse itself from the issuance of debt obligations in the future, an inducement resolution is required by state and federal law. The resolution must contain certain information and is generally reviewed by bond counsel to protect the tax-exempt status of the future issuance. The resolution must be passed not more than 60 days after the date that the cost to be reimbursed is paid. Failure to adopt a qualified declaration of official intent will prohibit the City from reimbursing the costs with the proceeds of tax exempt obligations. Reimbursement bonds generally must be issued 18 months after the later of, the date the expenditure was made, or the date that the project, with respect to which the expenditure was made, is placed in service.

This RCA is related to item 68955 to amend the Aviation Department Capital Budget by \$72,000,000. This requests

authorization for the Aviation Department to reimburse itself from future bond funds for the additional appropriation requested for the Hensel Phelps and Gensler contracts and a portion of the additional appropriation requested for the Austin Commercial contract.

The reimbursement resolution includes the amount of \$28,000,000 to correspond with the \$28,000,000 in appropriation requested to move forward with the Hensel Phelps (related item 68879) and Gensler (related item 68860) contract amendments for the increased scope of work for Terminal/Apron Expansion project. The Aviation Department and Airlines have identified additional needs that increases the construction cost limitation contract with Hensel Phelps and also the design contract with Gensler. The additional scope of work includes gate modifications, modifications to the mezzanine level, a centralized operations center, build-out of apron level airline tenant space and the replacement of aging baggage claim devices.

The reimbursement resolution includes \$12,000,000 of the \$44,000,000 in appropriation needed to move forward with the Construction Manager-at-Risk contract with Austin Commercial (related item 68565) for the construction of a parking garage, administration building and other garage entrance roadway improvements. A new 6,000 space public parking garage with highly desirable protected spaces will be constructed near the terminal building. A 70,000 square foot administration office building will be adjacent to the new garage and allow the Airport to free up revenue generating space on the mezzanine level of the terminal (currently occupied by several administrative groups). Improvements to the entrances to the long term and close-in parking lots to improve traffic flows and new overhead signage on Presidential Boulevard are also part of the scope of the parking garage project.

Of the \$44,000,000 of additional appropriation needed for the Austin Commercial contract, \$32,000,000 was included in the 2017 Airport Revenue Bond Issue, therefore, reimbursement resolution authorization is needed only for \$12,000,000 of the additional appropriation.
