<b>Additional Backup Information</b>	
<p>As requested by Council at the December 15, 2016 Council meeting, the Capital Contracting Office negotiated a Professional Services Agreement with CasaBella Architects and is returning to Council with a Recommendation for Council Action for the execution of the agreement.</p> <p>In the mid to late 1970s the idea to create a Mexican American Cultural Center (“Center”) was conceived by artists, students and community activists. Through their efforts, the City decided to support such a facility and in 1986 the City Council appointed a task force to develop a concept for the Center. In 1989 Council adopted a resolution designating land owned by the City at 600 River Street as the future site for the Center. As part of Proposition No. 4 on the November 1998 bond ballot, Austin voters approved bond authorization for the Center.</p> <p>The Center is dedicated to the preservation and promotion of Mexican American Cultural Arts and Heritage. Through education and community participation, the center fosters a meaningful understanding and appreciation of Chicano, Native American, and Latino cultures, with their respective artistic expressions.</p> <p>In 2000 City Council selected CasaBella Architects and its joint venture partner, Del Campo &amp; Maru to develop the original Emma S. Barrientos Mexican American Cultural Center Master Plan. The firm was selected as the top-ranked firm through a competitive Qualifications-Based Selection process to perform the original master plan. CasaBella Architects also oversaw the subsequent design and construction of Phase I of the Center, which was completed in 2007. CasaBella and its joint venture partner, Del Campo &amp; Maru designed the Center to be highly energy efficient utilizing green/sustainable concepts. Also, the project was designed to protect the environmentally sensitive Lady Bird Lake/Waller Creek site.</p> <p>Since the adoption of the original master plan, there have been several developments that necessitate a new master plan be developed prior to moving forward with any subsequent design phases. These developments include:</p> <ul style="list-style-type: none"> <li>• Rezoning of Rainey Street from Single Family to Central Business District zoning;</li> <li>• Mexican American Cultural Center property is now dedicated parkland;</li> <li>• Additional City owned properties are now part of the Mexican American Cultural Center property, and</li> <li>• Programming at the Mexican American Cultural Center that provides better opportunities to meet community needs.</li> </ul> <p>Major elements to be addressed in the new master plan include:</p> <ul style="list-style-type: none"> <li>• Buildings, programming and phasing;</li> <li>• Plaza improvements;</li> <li>• Building and site circulation such as how visitors interact with the facility;</li> <li>• Integration of the waterfront including trail access and design integrating the waterfront and trail into the overall site design;</li> <li>• Utilities including water, electricity, sanitary, and planning for future utility needs;</li> <li>• Landscaping; and</li> <li>• Design of new parkland and “La Gran Entrada” or grand entrance.</li> </ul>	

The new design and master plan's vision will be reflective of the site's current conditions, context, programming needs and community desires. Due to the CasaBella's experience and expertise with the Center, the community, and their demonstrated competence and qualifications determined through their initial selection through the City's Qualifications-Based Selection process, the Parks and Recreation Department believes that CasaBella is the most qualified provider to develop the new master plan.

This request allows for the execution of a professional service agreement with Casabella Architects based on their selection as the top-ranked firm through a competitive Qualifications-Based Selection process for the original master plan. Casabella will perform design services for the Emma S. Barrientos Mexican American Cultural Center Master Plan, including design development for two parcels of parkland recently added to the campus.

This is not a time sensitive item however work on the master plan update cannot commence if this recommended action is not approved.
