## 2. CITIZEN COMMUNICATION: GENERAL

- 1. Bonnie Cullum, Artistic Direct for the Vortex Rep Theatre Core PS III is a hardship for the individual artists and for the fiscal sponsors because it is now an annual process.
- 2. Krystle Kelly, Vortex Repertory ZoomGrants The site crashing during peak times, streamline the fiscal sponsor documents so that it is only they only need to upload once, receipts uploaded individually is a burden.
- 3. Melissa Vogt, Vortex Repertory Community Initiatives the artists applied for CI funding in the fall but funding was not available (event was in October) so the Vortex had to front them funds so that they could complete the project. Consider the only opening applications up to in the Fall for Winter projects \$3,000 is enough for an individual artists.
- 4. John Riedie, CEO, Austin Creative Alliance Institution Theatre will be closing at the end of the month. What is the \$200,000 from the Mayor's Focus Group could be used to subsidize extended hours at City facilities and cultural spaces.
- 5. Alexandra Bassett Rude Mechs Mechs will be out of their space on the 15. Will host a final new work show and a "Bon Fire" party on March 13<sup>th</sup>. Rude Fusion is also kicking off March 3 18<sup>th</sup>.
