WHEREAS, the Environmental Commission has previously made a recommendation to City Council (20160420 007b) to recognize Dr. Maxwell with a number of options including the renaming of the Slaughter Creek Management Unit.

WHEREAS, she worked tirelessly to preserve Austin's neighborhoods and unique character, and worked with neighborhood residents to address and manage the impacts of Austin's rapid growth; and

WHEREAS, she was a strong, zealous, and influential advocate in protecting the unique and sensitive Austin environment, most particularly Barton Springs and the Barton Springs portion of the Edwards Aquifer Recharge Zone; and

WHEREAS, she tirelessly shared her time, talents, and wisdom with others in the community to promote awareness of environmental issues and worked with others to find solutions to issues; and

WHEREAS, she showed unique talent in listening to all sides of sensitive environmental issues and worked to find a resolution that would address those issues; and

WHEREAS, she also served on the Waterfront Overlay Task Force, Lake Austin Task Force, and Board and Commission Transition Task Force providing leadership and guidance to each of these critical Austin endeavors; and

THEREFORE, in recognition of the outstanding and selfless contributions and leadership provided to the Environmental Commission and the City of Austin, the Environmental Commission stands in honor of Dr. Mary Gay Maxwell and her decades of service in protecting Austin's environment and neighborhoods; and

THEREFORE, to encourage fulfillment of Dr. Mary Gay Maxwell's legacy, the Environmental Commission recommends the naming of Slaughter Creek tract in her honor, the naming of the Trautwein Homestead education center in her honor, and the planting of a tree at Austin's City Hall.
