Partnership Proposal

Seeking partnership for use of the 3rd floor of the Sobriety Center to for the Homelessness Outreach Street Team

Seeking agreement to identify this partnership as a matching grant commitment to the Bloomberg Innovation Team grant when it goes before City Council to amend the budget

Bloomberg Philanthropies Grant

- Selected Austin as one of 7 cities with a demonstrated commitment to designing and delivering bold solutions to complex problems
- Awarded Austin up to \$500,000 annually for up to three years to fund an innovation team to increase capacity to address the Mayor and City Council's priority focus on ending homelessness.
- Will work closely to support Austin community partners—offering them a different set of tools and techniques:
- Build empathy for the people impacted by the problem as a way of understanding the problem
- Co-create and test solutions that deliver meaningful results for community

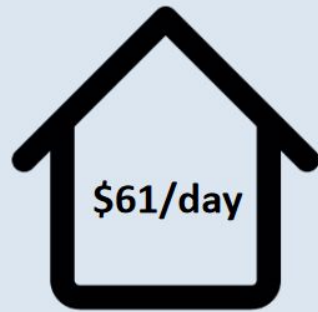

Goal

- Prevent the individuals from reaching a point where the 9-1-1 system is their only option by...
- Collaborating with resources to develop comprehensive solutions to...
- Connect individuals to resources that benefit their well being

Approach

- Recognize that unconventional individuals have needs that require unique solutions
- Consider alternative measures in developing a solution
- Collaborate to streamline efforts and provide swift, effective solutions

Target

- Frequent system users
- Vulnerable individuals at risk of deteriorating
- Provide additional system response resource

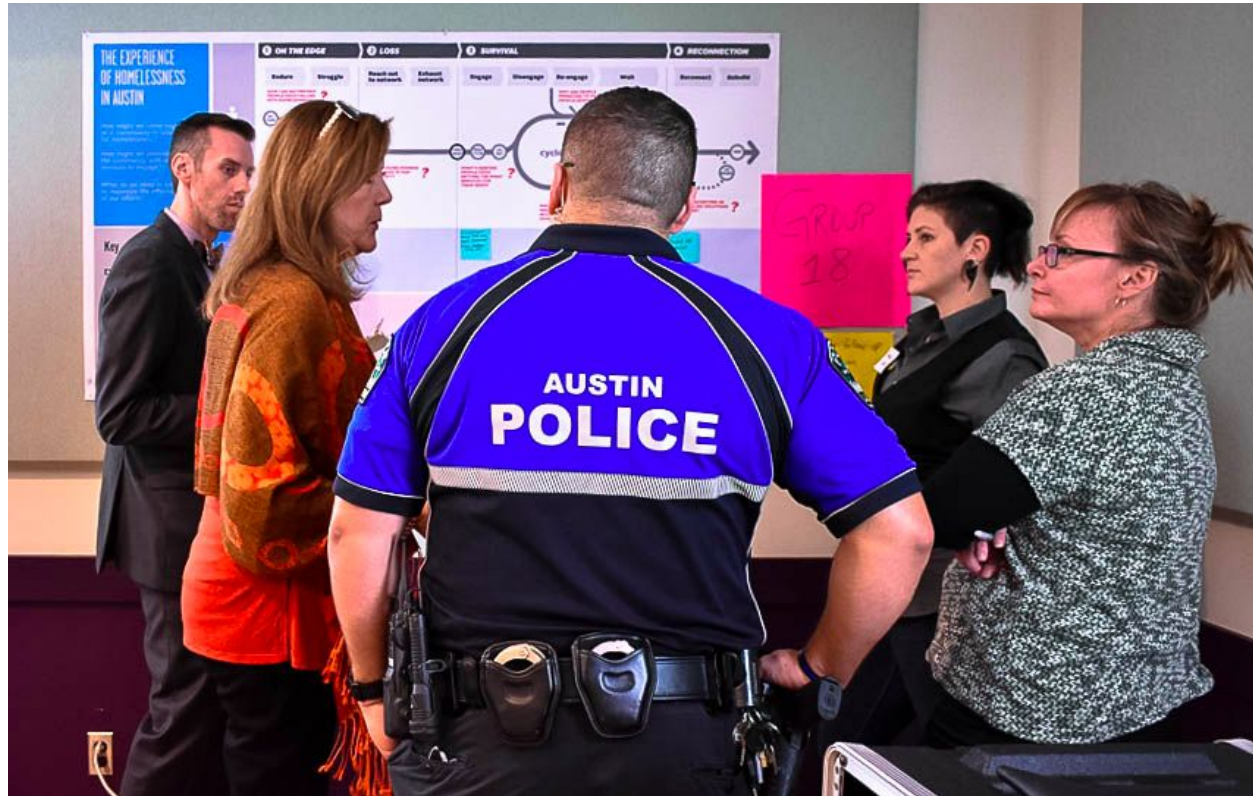

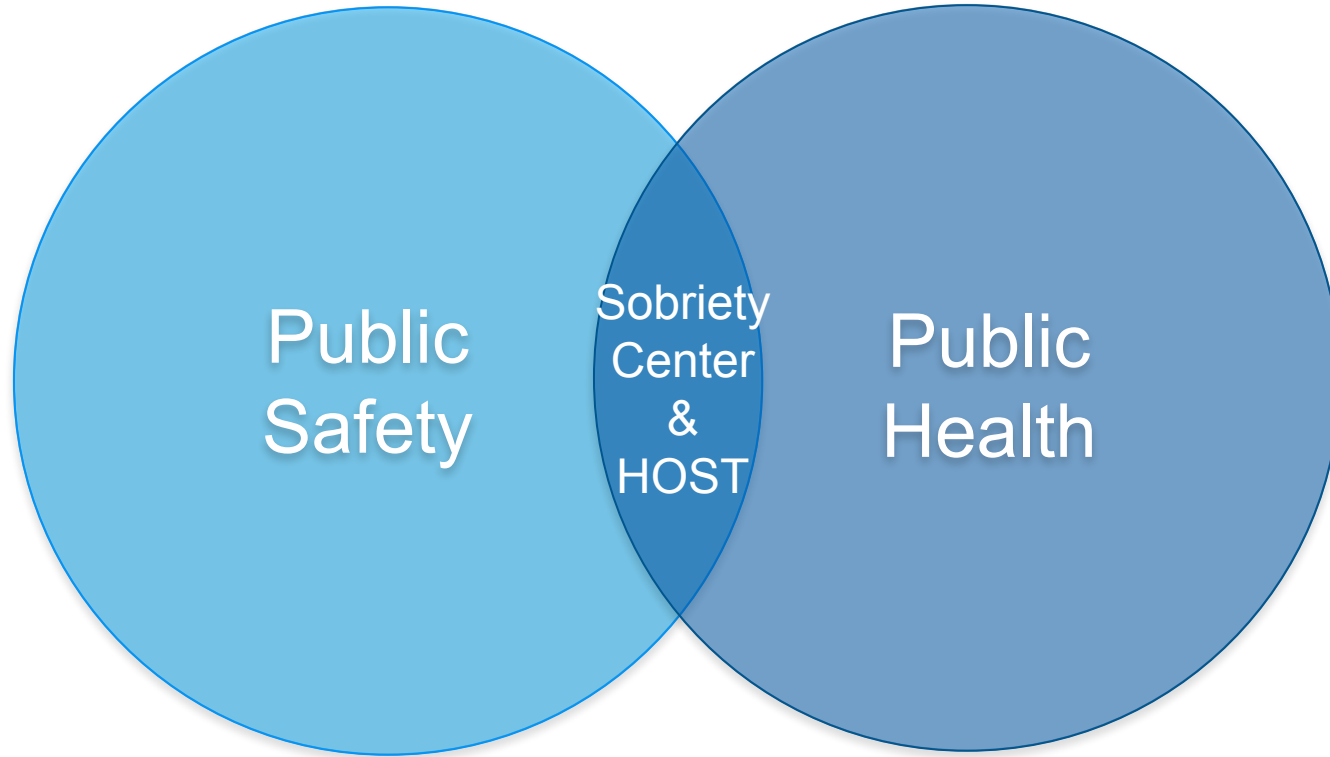

With service providers...

Working at the intersection of public safety, health, and social services, the innovation teams solve for *how might we...*

- Enable the better use of existing resources?
- Solve for including those with lived experience?
- Create shared understanding through community engagement?
- Solve for data and technology needs?
- Learn from the Dell Medical School's integrated teams approach?

Suggested Next Steps

1. Resolution declaring co-location of HOST on the 3rd floor of the Sobriety Center as intended to be an in-kind match for the Bloomberg Grant
2. Request for Council Action to amend budget to accept Bloomberg Grant
3. HOST and Bloomberg Innovation Team temporarily locate with Downtown Austin Alliance

System Gaps

Failure of a connection point or an intervention; a disconnect between clients' needs and delivered services

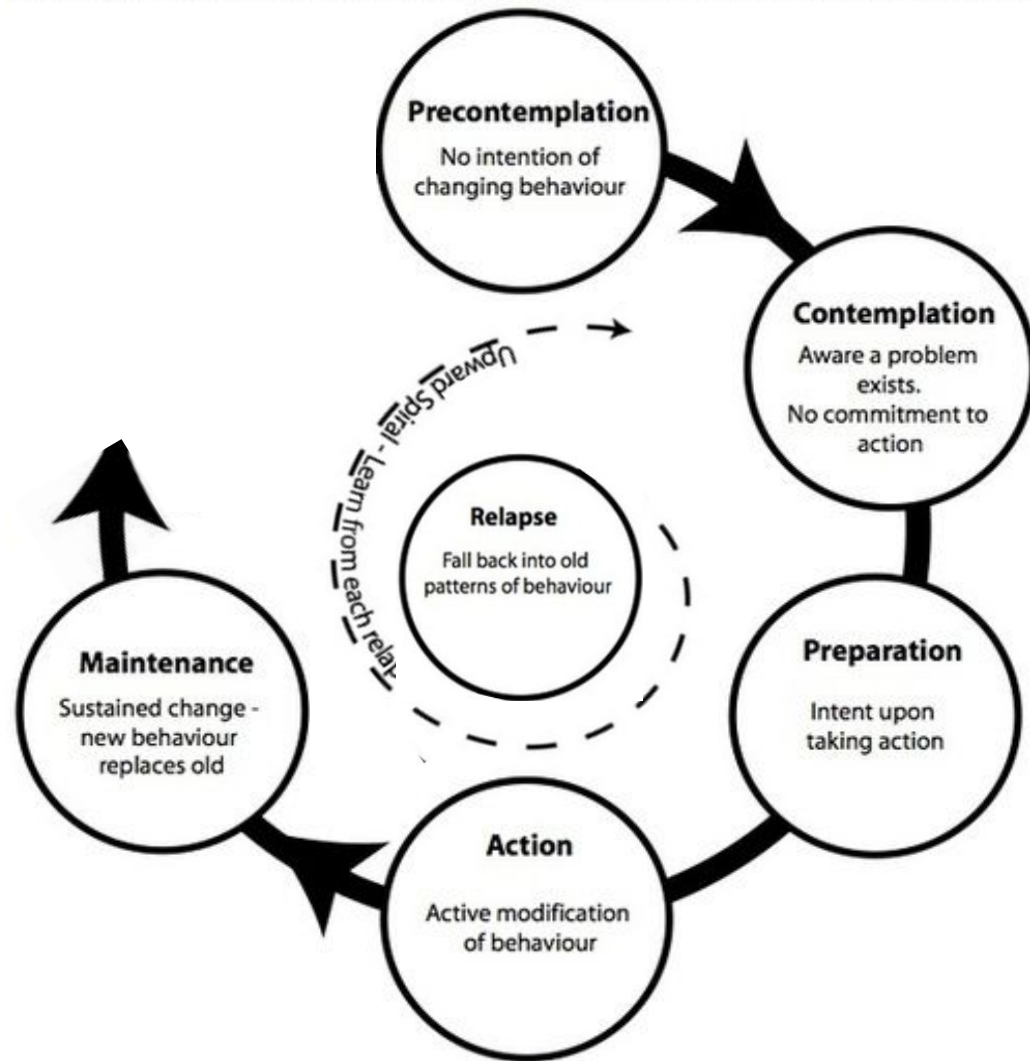
- Mental Health Services
- Jail entry/release
- Medical Services
- Detox & substance treatment

Cycle of change

A nonlinear process of overcome personal and social hurdles to make changes in daily life

Barriers include:

- Mental illness
- Trauma
- Substance dependency
- Lack of positive social support
- Distrust in others



Connecting to Continuum of Care

- “Be on the lookout” for service and housing providers who are looking for clients
- Creating more seamless hand-offs with community partners and services
- Immediate connection to resources when clients are ready to act
