SUBJECT

Authorize execution of change order #2 to the construction contract with **FACILITIES REHABILITATION**, **INC**. for the West Bank and Los Altos Lift Stations Rehabilitation project for the requested amount of \$74,626 for a total contract amount not to exceed \$1,526,711. (District 10)

AMOUNT AND SOURCE OF FUNDING

Funding is available in the Fiscal Year 2016-2017 Capital Budget of Austin Water.

MBE/WBE:	This contract was awarded in compliance with City Code Chapter 2-9A Minority Owned and Women Owned Business Enterprise Procurement Program by meeting the goals with 67.95% MBE and 16.95% subcontractor participation.	

The West Bank and Los Altos Lift Stations are located on the west side of Lake Austin. These lift stations serve as collection points for Austin Water sewer customers including a contracted amount of flow from the City of West Lake Hills. Wastewater from these lift stations is pumped across Lake Austin to larger trunk lines that transport the sewage to the South Austin Regional Wastewater Treatment Plant. Both stations were constructed over 30 years ago and equipment at both are at the end of their useful service life.

The construction includes rehabilitating both lift stations to ensure continuous and reliable service. The Los Altos station is being rebuilt at the same site and will include new submersible pumps and a new wet well. The West Bank station is being retrofitted with one additional pump to ensure appropriate redundancy. Each lift station will receive upgrades to their electrical and controls systems and will be fitted with emergency generators to protect against overflows due to loss of power.

The request for Change Order 2 comprises several small additions or corrections that were not apparent during original design. This request will also provide repairs to the aged and deteriorated wet well at the West Bank Lift Station. The work will include bypass pumping to evacuate and enter the wet well; removal of accumulated sludge; unclogging Pump #3's suction piping; water blast cleaning of the concrete walls, and lining of the entire wet well with an impervious concrete coating. A delay approving this change order will result in the postponement of the rehabilitation of the wet well on the West Bank Lift Station and the use of Pump #3. This will prolong startup and use of the Lift Station at its full pumping capacity, and delay completion of the project.

The contract allows 330 calendar days for completion of this project. This project is located within zip code 78746 (District 10), and is managed by the Public Works Department.

Facilities Rehabilitation, Inc. is located in Taylor, Texas.


