	<p><b>Open Governance Efforts</b></p> <ul style="list-style-type: none"> <li>• In short, it's a commitment the City made as part of our <a href="#">membership in the Open Government Partnership</a> to bring together open government and “smart cities” projects to share knowledge, connect with experts, and access tools and guidance to navigate challenges and achieve results. Everyone at the City owns open gov—we want to bring these projects together into a more connected portfolio and community of practice. <a href="#">More background on this project is available here.</a></li> <li>• We recently presented <a href="#">initial research insights</a> to the Open Government Operating Board on how we might help projects address challenges and solve problems. The findings highlighted the need for more user-friendly guidance and tools (distinct from policy that dictates what projects must do or not do), as well as more staff-to-staff collaboration across departments.
