

M/WBE Summary

Notification of the issuance of a Request for Qualifications solicitation was released on November 21, 2016 through the City's Vendor Connection web portal resulted in 52 firms receiving notice. The solicitation was obtained by 64 firms and 17 submitted qualifications statements. Five of the firms were certified MBE/WBE firms.

The City's Small and Minority Business Resources Department has determined that no goals are appropriate for this solicitation. Although no goals have been established for this solicitation, the firms were required to comply with the City's MBE/WBE Procurement Program if areas of subcontracting were identified. The following recommended firms have complied with the City's MBE/WBE Procurement Program in subcontracting areas identified, and were approved by the Small and Minority Business Resources Department.
