a. Texas Biennial presented by Shea Little and Leslie Moody Castro – Texas Biennial is an independent survey of contemporary art in Texas. Ms. Castro is an Independent curator who works between Texas and Mexico City. The Biennial was inspired by the history of biennials around the world. Desire to expand throughout the state. The previous biennials have been Austin focus, with calls for artists from around the state. In 2011 they partnered with over 80 organizations around the state. In 2013 was the first year that actually had state wide exhibitions. 2017 Biennial will return to Austin. A month and a half long tour of Texas will be part of the Biennial preparations. Ms. Castro will visit the 60 organizations throughout the state that are participating. Want to do a conference series to talk about the state of the arts in Texas. Exhibition will open in late September and will run through December.
