The contract is for the purchase of a new aqueous ammonia heater skid for the combined cycle electricity generating				

The contract is for the purchase of a new aqueous ammonia heater skid for the combined cycle electricity generating unit at Austin Energy's Sand Hill Energy Center. The contract includes the removal and disposal of the existing skid, manufacturing and installation of a new skid, and equipment start up. This equipment is replacing the original skid installed when the combined cycle unit was built in 2004. The original skid has been requiring more extensive maintenance to maintain reliability of the unit.

The aqueous ammonia heater skid is part of the combined cycle unit's emissions control system. The skid vaporizes aqueous ammonia for use in the unit's heat recovery steam generator resulting in the reduction of nitric oxide and nitrogen dioxide emissions which is required for the combined cycle unit to meet the air permit requirements.

An evaluation team with expertise in this area evaluated the offers and scored Peerless Mfg. Co. as the best to provide these goods and services based on technical concept and solution, experience and qualifications, schedule, cost and

local business presence.

This request allows for the development of a contract with a qualified offeror selected by Council. If the City is unsuccessful in negotiating a satisfactory contract with the selected offeror, negotiations will cease and staff will return to Council so that another qualified offeror may be selected, authorizing new contract negotiations.
