HISTORIC LANDMARK COMMISSION APRIL 24, 2017 DEMOLITION AND RELOCATION PERMITS HDP-2017-0144 509 E. LIVE OAK STREET

PROPOSAL

Demolish a ca. 1923 house.

ARCHITECTURE

One-story, rectangular-plan, pyramidal-roofed frame house with a full-width inset porch on found posts; single fenestration consists of multi-light upper sash windows on the front, and 1:1 fenestration on the sides; non-historic porch railing; transom over central, single-leaf front door.

RESEARCH

The house appears to have been built around 1923; the first owners and occupants were Alfred P. and Minnie Sedwick, who lived here until around 1928 with their family. The Sedwicks had lived in San Antonio in the early 1920s, where Alfred Sedwick was a house carpenter. They then moved to Austin, first settling in East Austin on Willow Street, where Alfred Sedwick worked as a yardman for the Austin Cattle Company. His several sons, who lived here in the house with him, were metal workers for J.O. Buaas and Sons; another worked for the Austin Sash and Door Company. While living in this house, Alfred Sedwick listed his occupation as a carpenter; the 1927 city directory does not show an occupation for him.

The house then became a rental property from the late 1920s until around 1948. The late 1920s and early 1930s saw a series of renters, but around 1936, the house was rented by William Franklin Adcock and his wife, Georgia. The Adcocks lived here until around 1942. William Franklin Adcock was a retired farmer. He had no occupation listed in the city directories while he and Georgia lived here, but they also had several employed children living with them.

Again in the mid-1940s, the house was rented by a succession of relatively short-term tenants; around 1948, the house was purchased by Gee Saul and his wife, Elvie. The Sauls lived here until around 1962. Gee Saul rarely listed an occupation in the city directories, but earlier census reports show that he had been a truck driver for the City Sanitation Division, and before that a construction laborer.

From around 1970 until very recently, the house was owned and occupied by the Calderon family. Ralph Calderon was retired, and died in 1975. His death certificate shows that he was a disabled taxi driver. His widow, Mary, continued to live here until her death in 2016.

STAFF COMMENTS

The house is listed in the Comprehensive Cultural Resources Survey (1984) as a Priority 2 for research.

STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, then relocation over demolition. This house is an excellent example of the transitional style of housing between the late Victorian-era vernaculars and the bungalows of the 1920s, and if it is sufficiently structurally sound, it should be preserved and rehabilitated in place. It also represents one of the earlier houses in this section of South Austin, and one that helped establish the context for development

in the neighborhood. If rehabilitation is not feasible, then staff recommends relocation over demolition, and while strongly encouraging the applicant to preserve this house, recognizes that it does not meet the criteria for individual landmark designation, and therefore must recommend release of the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center.

Purpose and Scope:

At your request in August 2016 I inspected the subject property. The findings resulting from the inspection on 01 September 2016 follow. The purpose of the inspection is to observe the structure and is to report the structural condition of the same as of the date of the inspection. The scope of the work includes a facilities inspection via routine visual means and is considered a **Level A** structural inspection per the National Academy of Building Inspection Engineers effective 01 March 2012. Additional information regarding guidelines established in Texas for conducting residential foundation structural inspections may be reviewed at: www.nabie.org, All findings and conclusions were drawn from this type work. Utilities and non-structural elements (such as interior and exterior trim, finishes and coverage's) were not evaluated.

Site Description:

The building is a single-story residence with an attached front wood deck. The building has a pier-and-beam type foundation, constructed over unknown fill; a wood frame wall system covered with wood siding siding; and a wood frame roof system with composition shingles. The lot slopes gently toward the street. The USDA/NCRS soil survey indicates the soils in the area consist of the Urban land to typically include clay soil. Typically soils in the area are considered expansive subject to volumetric changes caused by changes in the moisture content, i.e., are subject to shrink - swell as largely weather dependent.

Historical Background:

The structure appears to have been constructed early the last century.

Findings:

Findings include but are not necessarily limited to, those listed below. For the purposes of this report the front of the building faces north.

Observations of the roof structure indicate structural over-span conditions and a significantly sagging roof structure. Please reference photographs 3 and 9. Observations of the foundation indicate the original cedar (tree trunk) piers to remain with hybridized support means and methods. Please reference photographs 10 thru 12. Based on these observations this building is structurally unsound. The structural condition is beyond any reasonable means of rehabilitation hence demolition of this building from the site is advised.

Other:

I certify that I made this inspection as a professional engineer registered in the State of Texas, that I have no personal interest in the property inspected or anyone involved in the property, and this inspection was performed in a diligent manner in order to accurately represent the conditions on the date of the inspection. Various wall, floor, ceiling coverage's precluded a detailed inspection of some surfaces. Because of this, discrepancies that were concealed may have limited the accuracy of this evaluation. There was no geotechnical soils analysis available for review in preparing this report.

Alfred P. and Minnie Sedwick (ca. 1923 - ca. 1928)

The 1920 U.S. Census shows Alfred P. and Minnie Sedwick living in a rented house in San Antonio, Texas. Alfred P. Sedwick was 52, had been born in Texas, and was a house carpenter. Minnie Sedwick was 48, had been born in Texas, and had no occupation listed. They had 5 children: son Ollie, 17, a clerk at a government warehouse; Asa, 15, a delivery boy for a laundry; son Leslie, 12; Thomas, 10; and Lucille, 7. All the children had been born in Texas.

The 1930 U.S. Census shows Minnie Sedwick renting a house in Los Angeles, California with three of her children: Ollie, 28, and his wife, Glenn, 26; Thomas, 20; and Lucille, 18. Alfred P. Sedwick is not listed with them, nor does he appear anywhere else in the census records. Minnie Sedwick was 57, and is listed as married. She was born in Texas and had no occupation listed. Ollie C. Sedwick was a janitor in a bank; his wife, Glenn was a candy wrapper in a candy factory. Thomas Sedwick was a boilermaker's helper for a steam railroad, and Lucille Sedwick was a saleslady in a five and dime store.

The 1940 U.S. Census shows Minnie K. Sedwick renting a house in Los Angeles, California with her son Ollie, a 38-year old divorced man who worked as a bank janitor, her son Thomas, 30, who is listed as single, and worked as a rubber maker in a rubber factory, and a grandson, Charles, 7, who was born in California. Minnie Sedwick is shown as a 68-year old widow with no occupation listed.

His 1941 death certificate shows that Alfred Price Sedwick was living at 2105 Brackenridge Street, the home of his son, Asa, at the time of his death. He was born in 1869 in Texas and was a cattleman with commission pens.

William F. and Georgia Adcock (ca. 1935 – ca. 1942)

The 1920 U.S. Census shows William and Georgy Adcock living in a rented farmhouse in rural Travis County near Del Valle. William Adcock was 52, had been born in Texas, and was a famer. Georgy Adcock was 50, had been born in Texas, and had no occupation listed. They had 7 children: Dora, 32, a laborer on the home farm; son Allie, 22, a laborer on the home farm; Eugene, 15; Annie, 18; Claude, 12; Ruby, 10; and Sidney, 8. All of the children had been born in Texas.

The 1930 U.S. Census shows Frank and Georgia Adcock as the renters of a house on the Joppa Road in Burnet County, Texas. Frank Adcock was 62, had been born in Texas, and was a farmer. Georgia Adcock was 60, had been born in Texas, and had no occupation listed. They had two sons listed with them: Eugene, 25, a Texas-born farm hand; and Sidney, 18, who had been born in Texas and had no occupation listed. The household also included a grandson, Raymond Sheeley, 19, who had been born in Texas, and had no occupation listed.

The 1940 U.S. Census shows Frank and Georgia Adcock as the renters of this house. Frank Adcock was 72, had been born in Texas, and had no occupation listed. Georgia Adcock was 70, had been born in Texas, and had no occupation listed. With them lived two of their children: Eugene, 35, a laborer for the WPA; and Claude, 33, a laborer for a car wrecking company. Both Claude and Eugene Adcock had been born in Texas.

Georgia Adcock died in 1948 while living on a rural route in Travis County. She was born in 1869 in Caldwell County, Texas, and was a homemaker.

His 1949 death certificate shows that William F. Adcock was living on an Austin rural route at the time of his death. He was born in Caldwell County, Texas in 1867 and was a retired farmer.

ADCOCK: Mrs. Georgia Francis Adcock, 78, a resident of Austin for the past 40 years, died at her home on Route 6 Thursday night. She was a member of the Pleasant Hill Baptist Church. Surviving are her husband, Frank Adcock; four daughters, Mrs. Dora Barrow of Leander, Mrs. Sollie Sheeley of Lockhart, Mrs. Annie Tcague and Mrs. Ruby Johnson of Austin; four sons, A. E. The 1930 U.S. Census shows Gee and Elvie Saul living in a rented house at 1311 Holly Street in Austin. Gee Saul was a 32-year old Texas-born laborer for a construction company. Elivie Saul had no occupation listed. They had 5 children: daughter R.V., 11; son R.B., 6; Ruth, 4; Mary A., 12; and daughter Beta, 1. Also in the house hold were Gee Saul's brother- and sisterin-law, Willie and Mabel Thurman. Both were 15, had been born in Texas, and neither had an occupation shown.




