Important Dates

May 8 - Last day for House Committees to report HBs out of committee

May 9 – Last House Daily Calendar with HBs/HJR's must be distributed

May 10 – Last House Local & Consent Calendar with HBs must be distributed

May 11 - Last day for House to consider 2nd reading HBs/HJR's on Daily or Supplemental Calendar

May 12 - Last day for House to consider 2nd or 3rd reading HBs/HJR's on Supplemental Calendar

Revenue Caps

S.B. 2 (Bettencourt):

- Passed the Senate, March 22
- Referred to House Ways & Means, April 19
- Senate amended the cap from 4% to 5%
(\$24 less for Austin homeowner in property taxes and \$11.4 million less for City)

H.B. 15 (Bonnen):

- Cap remains 4%
- Rescind City ability to pay non-voter approved debt with debt service portion of tax rate
(Cost of \$21 million to M&O budget)
- Referred to Ways & Means, March 6

S.B. 4 (Perry) –

- Passed the Senate, February 8
- Vote: 20 aye, 10 nay
- Passed the House, April 27
- Vote: 94 aye, 53 nay,
1 PNV (Speaker Straus)



Bathroom Bill

S.B. 6 (Kolkhorst) –

- Passed the Senate and sent to House March 16
- Awaiting House Committee Referral

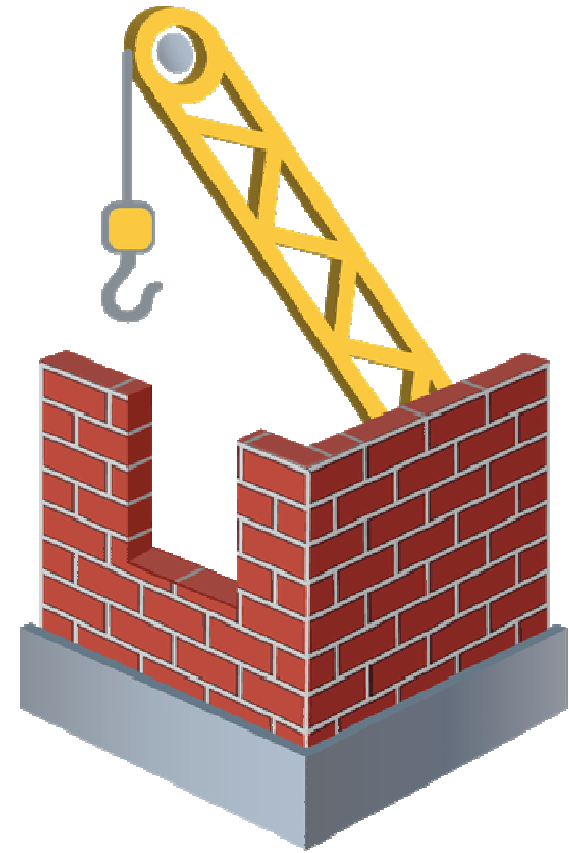

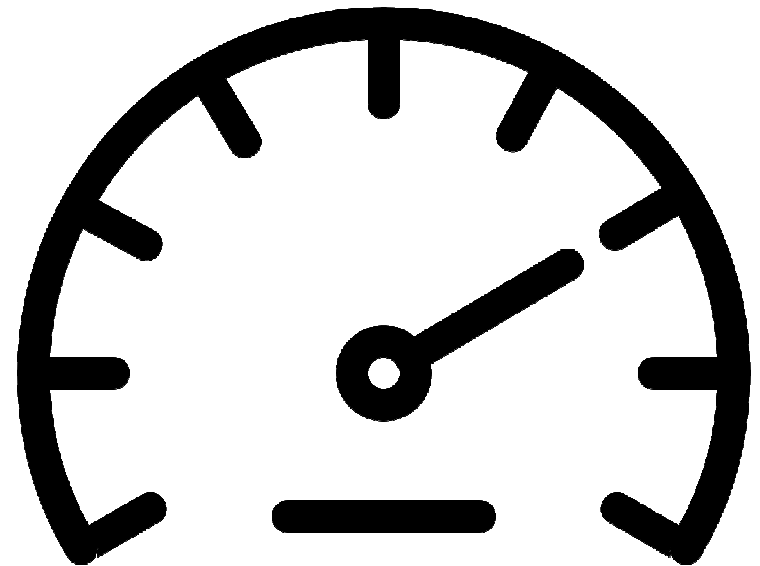

- Reported favorably as substituted from House Natural Resources, April 27

H.B. 3036 (T. King) – Discharges into Edwards Aquifer

- Prohibits TCEQ from amending or issuing new discharge permits
- Pending in House Environmental Regulation, April 11



Budget

- Passed by Senate, March 28
- Vote: 31 aye, 0 nay
- Passed by House, April 7
- Vote: 131 aye, 16 nay
- Conference committee set, April 24
- Senate Conferees: Nelson (Chair), Hinojosa, Huffman, Kolkhorst, Schwertner
- House Conferees: Zerwas (Chair), Ashby, Sarah Davis, Gonzales, Longoria
