## 1. APPROVAL OF MINUTES

The minutes from the meeting of March 20, 2017, were approved on Commission member Moore's motion, Commission Chair Canales-Zarate second on a 2-0 vote.

## 2. NEW BUSINESS

- a. Hear and act upon a disciplinary appeal from Fire Lieutenant Jamie Baxter before the Firefighters', Police Officers' and Emergency Medical Services Personnel's Civil Service Commission for an 8-hour suspension.
  - Commission member Moore made the motion to sustain the decision of the Fire Chief to temporarily suspend Fire Lieutenant Baxter, but

reduce the suspension to a period of four (4) hours. Commission Chair Canales-Zarate second the motion and the motion pass 2-0.

- b. Hear and act upon a disciplinary appeal from Fire Specialist Ryan Thompson before the Firefighters', Police Officers' and Emergency Medical Services Personnel's Civil Service Commission for an 8-hour suspension.
  - This Appeal was withdrawn by the appellant.
- c. Hear and act upon a disciplinary appeal from Fire Specialist Todd Zoch before the Firefighters', Police Officers' and Emergency Medical Services Personnel's Civil Service Commission for a 2-day suspension.
  - Commission member Moore made the motion to sustain the decision of the Fire Chief to temporarily suspend Fire Specialist Zoch, but reduce the suspension to a period of twelve (12) hours. Commission Chair Canales-Zarate second the motion, and the motion pass 2-0.
