The Department of State Health Services has provided funding for the purpose of augmenting local health department epidemiological capacity for outbreak and disaster response with special emphasis on foodborne illness investigations and emerging infectious diseases.

This request combines the two previously authorized awards and seeks the acceptance of additional funds in the amount of \$118,591 for a total of \$415,591 for the combined grant programs. The new grant will cover a two year period from September 1, 2017 to August 31, 2019.

The continuation of this funding affects the following performance measures:

- Percent of Foodborne Outbreak Investigation initiated within three hours.
- The number of cases investigated that result in an intervention strategy.
- Number of Emergency Response Plans reviewed annually.
- Ensure 1 epidemiologist per 100,000 population.

The General Fund will not be required to contribute additional funds beyond those currently budgeted to this grant. When the grant funds expire, the Austin Public Health Department's need for continuing funding will be evaluated and may be denied.
