The Commission on Seniors convened a regular meeting at City Hall in the Boards and Commissions Room -301 West  $2^{nd}$  Street, Austin, Texas 78701

#### 1. CITIZEN COMMUNICATION

- i. John Woodley
  - a. Drive through facilities without walk-in service should provide services for pedestrians and cyclists
  - b. Would like for the Commission on Seniors to recommend ways to improve access for seniors to services any time, not just when walk-in services are open

### 2. APPROVAL OF MINUTES FROM THE AUGUST 10, 2016 MEETING.

- Vice Chair Varteressian made a motion to accept the minutes.
- Commissioner Gray seconded the motion.
- Motion passed 11-0

### 3. NEW BUSINESS

- A. Briefing and discussion regarding the draft Austin Housing Plan (Jonathan Tomko, Senior Planner, Neighborhood Housing and Community Development)
  - Plan is still in draft form, and some numbers may change from presentation based

on public input

- Plan explores funding mechanisms, potential regulations, and other creative approaches the City of Austin and the community should utilize to achieve housing goals
- Discussion of timeline beginning with introduction of plan in Fall 2015, multiple layers of community engagement and public presentations, and the potential adoption of the Housing Plan as an amendment to Imagine Austin in the Winter of 2016/17
- Initial outreach included over 11,000 website views, 1,572 survey responses, 314 meeting attendees, 22 community meetings, 8 board and commission presentations, 6 email blasts, 5 media stories, and 1 fourth-grade class presentation
  - Public input included concerns about affordability, property tax increases, and need for more affordable housing including near public transit
  - Input addressed need to alter zoning regulations to allow tiny houses, accessory dwelling units, and smaller housing units, as well as more emphasis needed on utilizing land trusts as an affordable housing tool
- Great need for deeply affordable rental units for renters earning less than \$25K per year
- Challenges with geographically limited housing opportunities
- Rising housing costs causing long-term residents to seek affordable housing elsewhere
- Need for affordable housing near transit and services to enable seniors to age in place, provide choices for persons with disabilities, and to mitigate the financial impact of rising transportation costs
- Wages have remained flat while home prices and rents are rising quickly
- Land Development Code impacts how much land is available for attached units
- Future housing demand will be impacted by 400,000 additional people expected in Austin by 2045
  - Need 200,000 additional units over next thirty years to meet demand
    - Increase in millennials, boomers, and single people
      - Increased demand for smaller housing options
- Cost of closing Austin's affordable housing gap today is about \$6.48 billion
- Cost of closing Austin's affordable housing gap expected by 2025 is \$11.18 billion
- Risks of losing Austin residents, becoming more economically segregated, increased traffic congestion as people are forced to move out of the city, and becoming a city that is only affordable to the rich
- Proposed 10 year housing goals
  - 75,000 units in 10 years
    - 35,000 affordable units (80% MFI and below) and 40,000 market rate
- Housing Plan Key Policies and Programs
  - Prevent households from
- John Woodley signed up as a speaker
  - Spoke regarding comparing affordable and low-income housing
  - Housing options seemed to be geared toward families rather than individuals
- Discussion regarding whether home repair programs are included in the plan, and overall timeline for input

- Motion by Vice Chair Varteressian to recommend that the Austin Housing Plan reference Domain 3 recommendations from the Age-Friendly Community Action Plan, and specifically highlight suggestion to increase outreach and resources for home repair, and have a percent of housing funds set aside for homes for seniors based on the number of seniors in the community
- Motion seconded by Commissioner Gray
- Motion passes 11-0
- B. Discussion regarding a recommendation from the Social Participation, Respect and Social Inclusion Working Group regarding identification of programs supporting recreation, leisure, and educational activities that serve older adults
  - Discussion regarding draft recommendation letter; desire expressed to broaden approach
  - Debate regarding whether request should be directed to individual departments or City Manager's office, and whether it should be a letter of request or formal recommendation
  - Motion to draft letter that follows proposed resolution with language that requests a
    meeting and that information regarding programs and funding for seniors be
    gathered by Commissioner Lugo
  - Motion seconded by Commissioner De Maria Nicola
  - Motion passes 10-0-1 with Commissioner Gray off the dais
- C. Potential adoption of the 2017 calendar for standing Commission on Seniors meetings
  - Discussion regarding the upcoming joint meeting with the Mayor's Committee for People with Disabilities
    - Dates still pending
  - Motion to pass proposed calendar by Commissioner Gray
  - Motion seconded by Commissioner Van Sickle
  - Motion passes 11-0

    - a. Committee had outside participation and need to focus on getting educated regarding all issues related to housing and outdoor spaces
