Actions Alleged to be a Violation*
<p>10/6/16 - King requested a postponement of Appeal of case on behalf of neighborhood association on matter before the Board in which he likely would be presenting.</p> <p>10/10/16 - King remained on dais for consent vote in connection with Appeal case but noted he was abstaining from postponement item.</p> <p>11/14/16 - King requested postponement of Appeal again as applicant, but met in Executive Session with other board members when matter was discussed. Later argued against scheduling a Special Called Meeting to hear Appeal case.</p> <p>11/21/16 - King supplied applicant with e-mail correspondence he obtained from City staff, apparently in his capacity as member of Board.</p> <p>12/12/16 - King recused himself from consideration of Appeal for, among other things, having ex parte communications, but after moving from dais to behind AV stand, King instructed staff which slides to show to assist applicant; interjected his opinion to Board about procedure; and advised other speakers for applicant during consideration of item by Board.</p> <p>12/13/16 - King e-mailed neighborhood association members relaying Appeal was denied but shared information relating to Board members' discussions about the case he had overheard in the "breakroom," and that he would begin application for reconsideration.</p> <p>12/21/16 - King assisted in compiling evidence and support to be used at the later hearing and in formulating the presentation to the Board. King continued to participate in and investigate the case in conflict with the Board's Rules of Procedure.</p> <p>02/27/17 - After Appeal and motion to reconsider were denied, King e-mailed neighborhood association members urging the filing of additional appeals.</p>
