#### **CALL TO ORDER**

Meeting was called to order at 6:35 PM

#### 1. CITIZEN COMMUNICATION: GENERAL

The first ten speakers signed up prior to the meeting being called to order will each be allowed a three-minute allotment to address their concerns regarding items not posted on the agenda.

No citizens signed up for general citizen communications.

#### 2. APPROVAL OF MINUTES – March 8, 2017

Minutes from the Commission's regular meeting of March 8, 2017 were approved on Commissioner Clarke's motion; Commissioner DasGupta's second, on a vote of 9-0.

# 3. NEW BUSINESS (Discussion and Possible Action)

a. Election of CTTC Officers

<u>Commissioner Yeatts nominated Commissioner Clarke to continue as Vice Chair,</u> <u>Commissioner Clarke accepted, and the nomination failed on a 1-8 vote</u>

(Commissioner Pitts' excused absence, Commissioner Vaughan unexcused absence)

<u>Chair Williams nominated Commissioner DasGupta, Commissioner DasGupta accepted</u> <u>the nomination, and the nomination succeeded on a 9-0 vote</u>

(Commissioner Pitts' excused absence, Commissioner Vaughan unexcused absence)

Commissioner DasGupta nominated Commissioner Clarke to be the new Chair, Commissioner Clarke accepted, and the nomination succeeded on a 9-0 vote

(Commissioner Pitts' excused absence, Commissioner Vaughan unexcused absence)

#### 5. COMMISSION UPDATES (Discussion and Possible Action)

a. Commission Effectiveness Working Group.

This working group did not meet month, but will meet in the coming month.

b. Community Engagement Working Group.

Commissioner Yeatts noted that this working group is continuing to reach out to neighborhood groups to get them involved in taking classes from the City on how to get information from the City website. Several groups have expressed interest in and taken the classes

Chair Williams asked Commissioner Yeatts for a couple of testimonies or feedback from people who had taken the class by the June meeting.

### c. Civic Technology Working Group.

Commissioner DasGupta noted that Google Fiber has begun deployment in Southeast Austin, and will be moving towards central city. There is anecdotal evidence that AT&T is beginning to deploy fiber in Canyon Creek. He also noted that the permitting presentation will be heard in June, and the resolution will be further considered at that time.

### d. Open Government Working Group.

Commissioner Clarke noted that Commissioner Newell has created a mission statement for the Policy Lab's involvement in the ATX Hack for Change event: to create a technology that connects policy makers to relevant and timely open data so that they can use the data to make evidence based policy for our community. The next step is to submit this as a project proposal through the ATX Hack for Change process (by mid May). There is potential to garner student support from UT. The project name is "Policy Jam".

#### Open Government Operating Board:

Commissioner Clarke is interested in having a conversation about the data being collected by the City's public safety departments, and how that data is being shared with ICE. Other interested parties are Commissioner Floyd, Commissioner Newell, Commissioner Alexander, Commissioner Pruthi, and Vice Chair of the Public Safety Commission Daniela Nunez. There will be meetings held on this effort.

Commissioner Clarke also noted a possible area of interest on the Mayor's Taskforce on Institutional Racism and Systemic Inequities' Report: Collecting and analyzing data on disparities and outcomes in the criminal and civil justice system and dispositions by race. Commissioner Clarke is interested in having a discussion on this within the commission.
