### PROPOSAL

Demolish a ca. 1943 house.

### ARCHITECTURE

One-story, rectangular-plan, side-gabled, frame house with a full-width independent porch on ornamental metal posts; single 1:1 fenestration.

#### RESEARCH

The house was built in 1943 by day labor for Clemente and Jacinta Rodriguez, who lived here until around 1952. Clemente Rodriguez was a laborer. The house originally had an outhouse, according to the building permit. From 1952 onwards, the house was owned and occupied by John R. and Inez R. Salas. John R. Salas was a salesman, then truck driver for a produce company, and later became a driver for a brake and clutch service. He passed away in 2007.

### STAFF COMMENTS

The house is beyond the bounds of any City survey to date.

### STAFF RECOMMENDATION

Encourage rehabilitation and adaptive reuse, then relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center. The house has neither the architectural nor the historical significance to warrant individual designation as a historic landmark.

There is a notation on the census report that both were enumerated under the address of 1207 Red River Street. However, that record at 1207 Red River Street has not been located.


He was preceded in death by beloved wife, Jacinta Rodriguez.
