AN ORDINANCE AMENDING CITY CODE CHAPTER 2-5 RELATING TO PROCEDURES FOR CITY COUNCIL MEETINGS, PUBLIC HEARINGS, APPEALS, AND COMMITTEES, AND CITY CODE CHAPTER 15-9 RELATING TO UTILITY RATE HEARINGS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The title of City Code Chapter 2-5 (*Council Action, Meeting Procedures, Public Hearings, and Appeals*) is amended to read as follows:

CHAPTER 2-5. COUNCIL ACTION, [MEETING PROCEDURES, PUBLIC HEARINGS, AND] APPEALS, TERMS, AND COMMITTEES.

- **PART 2.** City Code Chapter 2-5 (*Council Action, Appeals, Terms, and Committees*) is amended to repeal Article 2 (*Procedures for City Council Meetings*). Article 2 is reserved for future use.
- **PART 3.** City Code Chapter 2-5 (*Council Action, Appeals, Terms, and Committees*) is amended to amend the title of Article 3 (*Procedures for Public Hearings and Appeals*) to read as follows:

ARTICLE 3. PROCEDURES FOR [PUBLIC HEARINGS AND] APPEALS.

- **PART 4.** City Code Chapter 2-5 (*Council Action, Appeals, Terms, and Committees*) is amended to repeal Division 1 (*Public Hearings*) of Article 3 (*Procedures for Appeals*). Division 1 is reserved for future use.
- **PART 5.** City Code Section 2-5-65 (*Conduct of Public Hearing on an Appeal*) is repealed.
- **PART 6.** City Code Chapter 2-5 (*Council Action, Appeals, Terms, and Committees*) is amended to add a new Section 2-5-109 to read as follows:

§ 2-5-109 PUBLIC HEARINGS.

(A) If a public hearing before the council is required by the Code, but is not required by the Charter or by state or federal law, a public hearing before a council committee satisfies the requirement.
