M/WBE Summary

Public notice was given for this solicitation, CLMP217 2017 Corridor Mobility Preliminary Engineering Reports Rotation List, through the City's Vendor Connection web portal which resulted in 2198 firms receiving notification, 153 firms obtained the bid documents and 18 firms submitted qualifications statements. Responses were opened on February 16, 2017. Two of the 18 firms submitting were certified MBE/WBE.
