

### M/WBE Summary

Public notice was given for this solicitation, CLMC629, Local Mobility ADA Sidewalk and Ramp Improvement Group 19 City Wide - IDIQ, through the City's Vendor Connection web portal which resulted in 489 contractors receiving notification and 84 contractors obtained the bid documents. Three bids were received and opened on March 23, 2017. Two out of the three bids received were MBE/WBE certified firms. Muniz Concrete & Contracting, Inc. submitted the lowest responsive bid of three bids received:
