

M/WBE Summary

Participation subgoals stated in the solicitation were 1.90% African American; 9.00% Hispanic; 4.90% Native Asian; and 15.80% WBE. The recommended firms provided an MBE/WBE Compliance Plan that met the goals of the solicitation and were approved by the Small and Minority Business Resources Department.

Public notice was given for this solicitation, CLMP220 2017 Local Mobility Field Engineering for Pedestrian, Bikeway & Urban Trail Rotation List, through the City's Vendor Connection web portal which resulted in 1276 firms receiving notification, 122 firms obtained the solicitation documents and 13 submitted qualifications statements. Responses were opened on March 1, 2017. Four out of 13 of the firms submitting were MBE/WBE certified firms.
