**WORK SESSION MEETING  
TUESDAY, MAY 9, 2017**

**The City Council of Austin, Texas convened in a Work Session Meeting on Tuesday, May 9, 2017 City Hall at 301 W. Second Street, Austin, Texas.**

**Mayor Adler called the Council Meeting to order at 9:20 a.m.**
