

AUSTIN CITY COUNCIL MINUTES

REGULAR MEETING THURSDAY, MAY 11, 2017

The following represents the actions taken by the Austin City Council in the order they occurred during the meeting. While the minutes are not in sequential order, all agenda items were discussed. The City Council of Austin, Texas, convened in a regular meeting on Thursday, May 11, 2017 in the Council Chambers of City Hall, 301 West Second Street, Austin, Texas.

Mayor Adler called the Council Meeting to order at 2:08 p.m.

DISCUSSION ITEMS

3. Approve an ordinance amending the Fiscal Year 2016-2017 Budget Stabilization Reserve Fund Operating Budget (Ordinance No. 20160914-001) to transfer out \$3,500,000 to the General Fund; and amending the General Fund Operating Budget (Ordinance No. 20160914-001) to increase the transfer in by \$3,500,000 from the Budget Stabilization Reserve Fund; and appropriating \$3,500,000 to increase expenditures in the Austin Fire Department Operating Budget (Ordinance No. 20160914-001) to provide additional overtime funds that are needed due to the high number of sworn fire vacancies and the requirement to maintain four-person staffing requirements. This item was postponed to May 18, 2017 on Council Member Alter's motion, Council Member Flannigan's second on a 10-1 vote. Council Member Garza voted nay.

Direction was given to staff to provide the following information: the total number of hours of overtime being funded by this transfer; how many hours and what is the average hourly rate; how many hours and the dollar amount that this translates per person on the force; has this been a trend and for how long has this overtime been a trend; what are the opportunity costs and budget implications with approving this request.

9. Approve a resolution directing the City Manager to create a Student Commission, which will make recommendations to Council on topics that affect or have particular relevance to the higher-education student population. (Notes: SPONSOR: Mayor Pro Tem Kathie Tovo CO 1: Mayor Steve Adler CO 2: Council Member Ora Houston CO 3: Council Member Leslie Pool) A motion to approve the resolution was made by Mayor Pro Tem Tovo and seconded by Council Member Houston.

The following amendment was made by Council Member Flannigan and seconded by Council Member Casar. The amendment was to revise the Be it Resolved clause to read: "The City Manager is directed to process amendments to City Code Chapter 2-1 brought by the City Council, relating to formation of an advisory board to be designated the Student Advisory Commission, and relating to the composition, functions, duties, and conduct of such commission." The amendment was later withdrawn without objection:

An amendment striking the following language in the Be It Further Resolved clause "The City Manager is directed to request" and replace it with "The City Manager is directed to consider approaches to composition of the commission, including requesting that

administrators..." was made by Council Member Kitchen, seconded by Council Member Casar. The amendment was accepted without objection.

An amendment to revise the Be It Further Resolved clause by replacing the language "each identify two student representatives" and replace it with "each identify two student representatives and the student government organizations on each campus identify one" was made by Mayor Pro Tem Tovo. The amendment was accepted without objection.

Resolution No. 20170511-009 was approved as amended above on Mayor Pro Tem Tovo's motion, Council Member Houston's second on an 11-0 vote.
