PROPOSAL

Demolish a ca. 1927 house.

ARCHITECTURE

One-story, wing-and-gable plan, frame house with a partial-width inset porch on turned wood posts; single 1:1 fenestration.

RESEARCH

The house appears to have been built around 1927. The first occupants were Thomas N. and Eula Henderson; Eula Henderson lived here until around 1930 after Thomas N. Henderson was killed in an automobile collision south of Austin near Buda in 1929. The house was then rented by two families named Mendez in the early 1930s; there is no information in the city directories about either of them.

Ollie and Viva Kuykendall rented the house in the mid-1930s, and are listed as the owners of the house from the late 1930s until the early 1940s. Ollie L. Kuykendall was a tile setter; he and Viva eventually moved to the Houston area. The house was again a rental property in the mid-1940s, then purchased by John and Nellie Salazar, who had previously rented it. The Salazars lived here until around 1950.

A series of Hispanic renters and owners occupied the house until the early 1970s, when it was rented by James and Mary Herrera, who were listed as the occupants of the house as late as the early 1990s. James Herrera was a cook for Matt's El Rancho Mexican restaurant.

STAFF COMMENTS

This house does not appear to meet the criteria for designation, either as a historic landmark or as a contributing structure to a potential local historic district due to recent modifications that have compromised its integrity of materials and design. The windows and siding have been replaced, and the porch rails are out of scale and not historic. The East Austin Historic Survey (2016) determined that this house is not eligible for individual designation or as contributing to a potential historic district due to the alterations.

The house does not meet the criteria for landmark designation as set forth in City Code:

- a. **Architecture.** The house is built in a vernacular style. It does not appear to be architecturally significant.
- b. **Historical association.** The longest-term occupants of the house were renters James and Mary Herrera, whose tenancy was not during the historic period. Otherwise, there do not appear to be any significant historical associations from prior occupants.
- c. **Archaeology.** The house was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
- d. **Community value.** The house does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, East Austin, or a particular demographic group.

- e. **Landscape feature.** The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.




STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, then relocation over demolition, but release the permit. The preparation of a documentation package for this house does not appear to be warranted given the level of modifications, but the house does appear to be sound and could be a good candidate for relocation rather than demolition.

BIOGRAPHICAL NOTES**Thomas N. and Eula K. Henderson (ca. 1927 – ca. 1930)**

Eula K. Henderson appears in the 1930 U.S. Census as living on Willow Street in Austin. She was 28, and married, although her husband is not listed with her. She was born in Missouri to an Illinois-born father and an Indiana-born mother, and was a laundress in a laundry. She died in 1935, a victim of tuberculosis. She was a 33-year old widow who was living at 1603 Canterbury Street at the time of her death. She was born in 1902 in Missouri and was a laundry employee. Her husband was Tom Henderson. Both are buried in the Live Oak Cemetery in Manchaca, Texas. Tom N. Henderson died in a 1929 auto accident. His death certificate shows that he was a farmer who had been born in Tennessee. He was living in this house at the time of his death.

One man was killed and eight were injured in a head-on collision of two automobiles three miles south of Buda early Sunday afternoon.

Tommie Henderson, 29, of 2211 Garden, Austin, died within an hour after the wreck at an Austin hospital. Concussion of the brain was given as the direct cause, though he was badly lacerated about the body.

George Scholl, also of Austin, was seriously injured. His body and face were badly bruised and cut, and doctors feared that he might have internal injuries.

J. E. Hopkins, H. E. Arnett, G. E. Mills, Elmer Brown and A. M. Gray of Crescent, Okla., and Otis Robins of Oklahoma City suffered minor cuts and bruises. They were given first aid at Kyle.

Eye-witnesses say that Scholl and Henderson were driving north in a small touring car and were attempting to pass another car when the head-on with the heavy sedan, occupied by the six Oklahoma men, occurred. Scholl, driver of the touring car, was thrown clear of the wreckage but Henderson was pinned beneath.

A passing tourist picked up Henderson and Scholl, both unconscious, and rushed them to an Austin hospital. Henderson died within five minutes after his arrival here. Scholl later regained consciousness and was able to piece in bits of the story.

Both cars were badly damaged in the crash.

Henderson had been in ill health for some time and had been to New Braunfels to consult a physician. He had lived until recently near Buda, where he was a farmer.

He is survived by his father and mother, Mr. and Mrs. S. T. Henderson of Buda, his wife and two small sons, one sister, Mrs. Sadie B. Harris of Austin, and two brothers, S. E. Henderson of Austin and R. M. Henderson of Buda.

Funeral services will be held Monday evening at 8 o'clock in the Live Oak cemetery. Services will be conducted by the Rev. Bradley of Buda.



Ollie L. and Viva Kuykendall (ca. 1933 – 1942)

The 1940 U.S. Census shows Ollie L. and Viva Kuykendall as the owners of this house, which was worth \$1,200. Ollie L. Kuykendall was 37, had been born in Georgia, and was a tile setter for a tile company. Viva Kuykendall was 36, had been born in Texas, and had no occupation listed. They had 4 children: son C.L., 16, who had been born in Alabama, and was a painter for an N.Y.A. project; daughter Helen, 13, who had been born in Alabama; son Thomas J., 9, who had been born in Texas; and son Gregorian M., 2, who had been born in Texas. None of the younger children had an occupation shown.

The 1930 U.S. Census shows O.L. and Viva Kuykendall living in a rented house at 215 W. 8th Street in Austin. Both were 26. O.L. was a tile layer in buildings. Viva had no occupation listed. Their two oldest children, C.L. and Helen, are listed in the census report.

Ollie Lucius Kuykendall died in Houston in 1979. He had been living in Houston for 7 months, and was a tile setter. He was born in 1903 in Georgia, and was divorced. He was buried in Houston. Viva Kuykendall died in Katy, Texas in 1995. There were no obituaries in the Austin newspapers.
