# **Community Development Commission (CDC)**

The Community Development Commission mission statement (per the City Code) is:

The purpose of the board is to advise the council in the development and implementation of programs designed to serve the poor and the community at large with an emphasis on federally funded programs.

#### **RECOMMENDATIONS TO CITY COUNCIL**

#### Fiscal Year 2016-17 Action Plan – Recommendation 20160712-05a

On July 12, 2016, the CDC approved a recommendation to approve the City's Fiscal Year 2016-17 Action Plan with edits outlined in the change log. The CDC also recommended allocating an additional \$500,000 from the Housing Trust Fund to the Home Repair Program.

#### **Cactus Rose Mobile Home Park – Recommendation 20160712-05b**

On July 12, 2016, the CDC approved a recommendation that City Council pursue emergency rezoning of the Levander Loop (also known as Gardner Road) site, designate it as a site for the relocation of Cactus Rose Mobile Home Park residents, and expedite the development of the site for those residents. The CDC further recommended that City Council deny the rezoning of the Cactus Rose site requested by the developer, unless the developer honors the Cactus Rose residents' plan to: 1) Remain on site, and that the developer accommodate them by constructing a new mobile home park there, and provide the residents with new or used mobile homes funded by the developer, or; 2) That City staff provide suitable City-owned land where the residents can relocate as a whole community to a new site within a 2.5-mile radius of the existing mobile home park, with funding for new or used trailers

provided by the developer, and with the City providing the land as a Community Land Trust.

#### **Tenant Relocation Policy – Recommendation 20160712-05c**

On July 12, 2016, the CDC approved a recommendation that City Council review recommendations by Heather Way, dated July 12, 2016, entitled, "City of Austin's Proposed Tenant Relocation Assistance Ordinance, Outline of Issues and Suggested Changes, Second Draft of Ordinance," and incorporate the changes recommended in that document, where appropriate, into the Draft Tenant Relocation Assistance Ordinance.

# <u>June 6, 2016 Draft Austin Strategic Housing Plan – Recommendation</u> 20160809-06b

On August 9, 2016, the CDC approved a recommendation that City Council consider a list of proposed changes to the June 6, 2016, Draft Austin Strategic Housing Plan.

#### Nexus Study on Linkage Fee Structure – Recommendation 20160913-05

On September 13, 2016, the CDC approved a recommendation to support Resolution 20160616-035 to identify funds for, and proceed to conduct, a nexus study to determine a linkage fee structure to advance affordable housing in Austin.

# <u>Cactus Rose Mobile Home Park – Recommendation 20161011-05</u>

On October 11, 2016, the CDC approved a recommendation to reaffirm its Recommendation 20160712-05b, in support of the Cactus Rose Mobile Home Park community. Additionally, the CDC recommended that City Council direct the City Manager to work with the Cactus Rose community to expeditiously secure a site such as city owned property at Levander Loop or privately owned property to which the community can relocate.

# <u>Updated Draft Austin Strategic Housing Plan – Recommendation 20170110-05a</u>

On January 10, 2017, the CDC approved a recommendation outlining amendments to the 2016 draft Austin Strategic Housing Plan.

#### Passive House and Affordable Housing – Recommendation 20170110-05b

On January 10, 2017, the CDC approved a recommendation that City Council study Passive House certification for all new affordable housing development, and initiate a study evaluating Austin's multifamily affordable housing buildings, including public housing, for the potential energy savings benefits of retrofitting.

### <u>Brownfields Recommendation – Recommendation 20170207-03b</u>

On February 7, 2017, the CDC approved a recommendation that City Council: require an Environmental Site Assessment for all city funded or permitted

affordable housing development, without exception, or for projects for which the City Council passes a resolution of no objection; expeditiously publish, in print and on the internet, publicly available maps of all brownfield sites located within the city limits and the city's Extraterritorial Jurisdiction (ETJ); update these maps annually; and, establish a Brownfield Revitalization Committee within the Joint Sustainability Committee dedicated to making policy recommendations.

# <u>CSBG Organizational Standards and Neighborhood Services Unit Strategic</u> <u>Plan – Recommendation 20170314-04b</u>

On March 14, 2017, the Community Development Commission (CDC) recommended approval of the Community Services Block Grant (CSBG) Organizational Standards and Neighborhood Services Unit Strategic Plan.

# <u>CDC Response to Fiscal Year 2017-18 Action Plan Community Needs</u> <u>Assessment process – Recommendation 2017411-3a</u>

On April 11, 2017, the Community Development Commission (CDC) recommended that the City utilize CDBG funds and Housing Trust funds to provide assistance to mobile home/manufactured home residents who are being displaced from their homes due to re-development of mobile/manufactured home sites.

# <u>CDC Recommendation on Mobile Home/Manufactured Home Parks – Recommendation 20170411-05</u>

On April 11, 2017, the CDC recommended that Austin City Council take the following actions:

- declare mobile home park evictions to be an emergency eligible for expedited permitting and development review,
- direct the City Manager to prepare the entirety of the Levander Loop property set aside as affordable housing for use as a mobile home park.
- set aside the property as a Community Land Trust,
- require that the mobile home park be managed by a local non-profit organization upon completion, and
- direct the City Manager to investigate ways to preserve or create housing opportunities where existing parks may cease to exist.

# Recommendation on the Preservation of the Montopolis School for Negro Children – Recommendation 20170613-04d

On June 13, 2017, the CDC recommended that Austin City Council:

- Support the Montopolis Community's desire to preserve and protect the school property in its entirety, to include the historic school building as well as the surrounding cultural landscape of which the school building is an integral part, which includes the property the city obtained via eminent domain, and Annual Review and Work Plan Year 2016 – 2017 Page | 4

> Initiate historic zoning for the school property and its surrounding cultural landscape, which includes the former church property located at 408 Montopolis Drive.

# Recommendation regarding the Mayor's Task Force on Institutional Racism Recommendations – Recommendation 20170613-06

On June 13, 2017, the CDC recommended that Austin City Council accept and embrace all of the recommendations of the Mayor's Task Force on Institutional Racism, particularly the recommendations of the task forces on real estate and housing, as well as public health. In addition, the CDC recommended that Council prioritize key tasks described in the recommendation.

#### 3. List the board's goals and objectives for the new calendar year.

- Advise Council on tools to support Homestead Preservation Districts, with emphasis on preservation of existing affordable housing stock and deep affordability (60% MFI and lower).
- Encourage a more "regional" approach to delivery of human services, especially to underserved areas where a physical site doesn't exist; research and advise City Council on a plan to enhance service delivery to the poor who lack access to a physical site.
- Where appropriate, encourage City/County partnerships in order to enhance delivery of services to the poor.
- Austin Strategic Housing Plan: Make recommendations on affordable housing plans, including unique funding mechanisms, strategies and revenue streams.
- Advise Council on, and grow the list of, outreach strategies to promote Cityfunded and grant-funded programs to the public, and seek more community involvement. Function as an advocacy group to empower and engage the citizens the CDC represents.
- Continue to monitor and make recommendations on Tenant Relocation Policy to include mobile home residents.
- Monitor and make recommendations on affordable housing incentive programs such as Vertical Mixed Use, Community Land Trust, Multi-family 6 and others to be determined.
- Facilitate filling vacant seats on the CDC.
- Explore and provide recommendations to Council on how public housing can help to solve Austin's affordability crisis.
- Explore micro lending as a tool to achieve more affordability (or aid individuals' transitions out of poverty) through low cost, free or forgivable auto title and payday loans.
- Permanent Supportive Housing (PSH): Work with City staff to ensure that the goal of adding 400 new PSH units by 2019 is accomplished.
- Make recommendations to City Council regarding *sustainability* in affordable housing, in terms of mitigating environmental impacts and making building code

improvements to produce measurable energy efficiency outcomes (like the "passive house" model).
