PROPOSAL

Demolish a ca. 1939 house.

ARCHITECTURE

One-story, rectangular-plan, side-gabled frame house with synthetic siding; front-gabled entry hood over the front door; single 1:1 fenestration.

RESEARCH

The house was built in 1939 by Truman Montandon, a local insurance man and developer. The house was rented for a few years by Solomon and Ernestine Harding, but neither had an occupation listed in the city directories. From around 1942 until his death in 1983, the house was owned and occupied by Elmo Sorrells, who operated a garage on the site as well from the mid-1950s through the mid-1960s. Elmo Sorrells grew up in rural Travis County, where his family eventually owned their own farm. His older brother worked as a mechanic in a garage, and Elmo was working as a serviceman for B.F. Goodrich, a tire and car care business on Lavaca Street, when he and his wife, Fannie, moved into this house.

STAFF COMMENTS

The house was recommended as contributing to a potential historic district by the East Austin Historical Survey (2016), but noted that many of the original materials on the house have been replaced.

The house does not meet the criteria for landmark designation as set forth in City Code:




- a. **Architecture.** The house is a frame late 1930s cottage, a common style. The house has no architectural distinction.
- b. **Historical association.** The house is most significantly associated with Elmo Sorrells, who grew up on a farm in rural Travis County, and had a garage here at the house where he did auto repair work. There do not appear to be significant historical associations.
- c. **Archaeology.** The house was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
- d. **Community value.** The house does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.
- e. **Landscape feature.** The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, then relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package.

BIOGRAPHICAL NOTES:

Elmo and Fannie Sorrells (ca. 1943 – ca. 1983)

Elmo Sorrells appears in the 1920 U.S. Census as the 9-year old son of Jacob and Ellen Sorrells, who lived in a rented house on an un-named road in rural Travis County. Elmo Sorrells is listed as a mulatto, and was the 4th oldest of the couple's 9 children. Elmo's father, Jacob Sorrells, was born in Texas to Virginia-born parents, and was a farmer. His mother, Ellen Sorrells was a farm laborer, as was the oldest child, Tenola, their 19-year old daughter. Jacob Sorrells, Jr., 14, was a section hand for the International and Great Northern Railroad.

The 1930 U.S. Census shows the Sorrells family living on the Manchaca – San Antonio Road in rural Travis County. Jake Sorrells owned his farm. Elmo's older brother, Theodore, was a mechanic in a garage. Elmo Sorrells, then 18, was a laborer for the railroad.
