

M/WBE Summary

Public notice was given for this Request for Qualifications CLMP227 the 2017 Asbestos, Lead Paint, and Mold Consulting Services Rotation List, through the City's Vendor Connection web portal, which resulted in 482 firms receiving notification and 49 firms obtaining the solicitation documents. Seven submitted qualifications statements and responses were opened on April 26, 2017. Of the seven of bids received two bids were from MBE /WBE certified firms.

The City's Small and Minority Business Resources Department has determined that no goals were appropriate for this solicitation. Although no goals have been established for this solicitation, the firms were required to comply with the City's MBE/WBE Procurement Program if areas of subcontracting were identified. The following recommended firms completed a no goals form and utilization plan that was approved by the Small and Minority Business Resources Department.
