Authorize award and execution of a 24-month contract with HD SUPPLY WATERWORKS, to provide brass pipe fittings, in an estimated amount of \$490,000, with three 12-month extension options in an estimated amount of \$245,000 per extension option, for a total contract amount not to exceed \$1,225,000.					
Amount and Source of Funding					
Funding in the amount of \$40,833 is available in the Fiscal Year 2016-2017 Operating Budget of Austin Water. Funding for the remaining 22 months of the original contract period and extension options are contingent upon available funding in future budgets.

Purchasing Language:	The Purchasing Office issued an Invitation for Bids (IFB) GLB0051REBID for goods on March 6, 2017 and it closed on March 23, 2017 with four offers received. **Additional Backup Information**

The contract is for the supply of brass pipe fittings for Austin Water. The line maintenance, construction, and field services divisions use these fittings in water services installation and repair. These parts are necessary to make the connection between the water main and the water service line by providing a reliable source of supply of various size and type of brass pipe fittings. The contract will enable service crews to connect new customer accounts and repair existing customer line breaks.

The contract will consolidate and replace two contracts which expired on June 30, 2017. The combined contracts averaged spend was \$234,900 per year. The variable demand of required brass fittings and the lead time to receive the necessary items makes it essential to maintain stock in the warehouse.

If the City is unable to secure a contract, the repair of City water pipes would be affected and potentially impact the City's ability to provide water to the citizens of Austin.
