

DBE Summary

Participation goals stated in the solicitation was 11.72% DBE. The recommended & alternate firm provided a DBE Compliance Plan that met the goals of the solicitation and were approved by the Small and Minority Business Resources Department.

Public notice was given for this solicitation CLMP225, Fallwell Lane Capital Renewal Project, through the City's Vendor Connection web portal, which resulted in 1663 firms receiving notification and 107 firms obtaining the bid documents. Three firms submitted qualifications statements and submittals were opened on April, 25, 2017. Of the Three submittals received none of the firms submitting were certified MBE /WBE.
