Authorize negotiation and execution of a 36-month contract with STRYKER CORP DBA STRYKER SALES CORPORATION, to provide maintenance and repair services for Styker emergency transport systems, in an estimated amount of \$2,295,000, with two 12-month extension options in an estimated amount of \$765,000 per extension option, for a total contract amount not to exceed \$3,825,000. <b>Amount and Source of Funding</b>				
Funding in the amount of \$318,750 is contingent upon approval of the proposed Fiscal Year 2017-2018 Operating Budget of the Emergency Medical Services department. Funding for the remaining 24 months of the original contract period and extension options are contingent upon available funding in future budgets.

**Additional Backup Information**

The contract will provide long term maintenance services including an annual preventative maintenance inspection for Stryker systems, powered ambulance stretchers, and stair chairs utilized by the Emergency Medical Services department (EMS). EMS currently has 240 Stryker assets in use that require preventative maintenance and repairs.

Stryker is the only authorized provider of maintenance and repair services for Stryker equipment. Service includes factory trained service provider(s) labor costs, on-site maintenance, and authorized replacement parts. Each Stryker asset requires an annual preventative maintenance inspection to maximize the asset's performance and peak service life.

This contract replaces an existing contract that expires September 29, 2017. This contract is for maintenance and repair on existing equipment. Authorization amounts are due to scheduled maintenance, anticipated and unanticipated repairs, and escalations in pricing.

Failure to approve the contract will result in EMS not having preventative maintenance or repairs on Stryker equipment which can void warranty and maintenance agreements resulting in additional costs to the City.
