Public notice was given for this solicitation CLMC645A DCP1 Cooling Tower Expansion-Rebid, through the City's Vendor Connection web portal, which resulted in 42 contractors receiving notification and 53 contractors obtaining the bid documents. Three bids were received and opened on June 29, 2017. Of the three bids received none of the firms submitting were certified MBE/WBE.
