# HISTORIC LANDMARK COMMISSION SEPTEMBER 25, 2017 APPLICATION FOR A NAME CHANGE FOR A HISTORIC LANDMARK C14H-1989-0022 Ruggles-Smith House 1600 Rio Grande Street

## PROPOSAL

The property owner requests that his name be added to the name of the house – from the Ruggles-Smith House to the Ruggles-Smith-Olian House.

## **PROPOSAL SPECIFICATIONS**

Mo Olian has owned the Ruggles-Smith house since July 30, 1974, and applied to designate the house as a historic landmark in 1989. He has owned the house for fully one-third of the history of the house, and has demonstrated significance in Austin's history. Mo first made headlines in 1961, when as student body president, he wrote a letter to the Board of Regents criticizing their decision to not integrate the university's dormitories and intercollegiate athletic facilities. The Board of Regents felt that the University had gone "farther than the citizens of the state would have approved" in integrating the campus, and demanded an apology from Mo Olian. Mo stood his ground and refused to apologize for the letter.

Mo then ran for a seat in the Texas House of Representatives in the late 1960s, but was defeated. He campaigned on a progressive platform, but was defeated. He ran again in 1972, but withdrew from the race.

Mr. Olian has been very active in many civic and philanthropic activities in Austin over the years, and his contributions to the Austin community have been recognized. He has been an active voice in preserving Austin's history, and has been a steady steward of the Ruggles-Smith House for 43 years. He hosted the only reunion of UT student body presidents at the house in conjunction with the UT Centennial in 1983.

#### STANDARDS FOR REVIEW

The Commission has no set policy for naming historic properties. The general practice has been to recognize the original owner along with subsequent owners of consequence with associations to the property within the historic period (50 years ago).

#### STAFF RECOMMENDATION

Consider a policy that might permit a name change if the change would recognize an owner of significance during the historic period, or the significance of a later owner during the historic period.

# Olian Asks 'Backbone' For Laws

Maurice (Mo) Olian, State Representative caudidate from Travis and Burnet counties, told a coffee gathering Monday that "we must have the backbone to pass strong legislation that will assure public confidence in allour elected officials."

Speaking on "Ethics in Government," Olian outlined three specific steps at the coffee, held in the South Austin home of Mr. and Mrs. John Barger, 1807-A Blue Crest.

"We must have legislationthat stops legislator-attorneys from practicing for pay before state agencies. This influence peddling must be halted," Olian declared.

Public disclosure of all sources of income of all elected state officials "is a necessary step" Olian said. "This is a price that a person who chooses to enter public life must pay."

Olian also called for strict enforcement of the Open Meetings Act which was passed by the last session of the legislature. "Meetings which are supposed to be held in public still are being held behind closed doors throughout Texas," Olian explained, and "the public's right to know must be upheld."
