

## M/WBE Summary

Public notice was given for this solicitation CLMC668, Asphalt & Concrete Repair IDIQ, through the City's Vendor Connection web portal, which resulted in 397 contractors receiving notification and 53 contractors obtaining the bid documents. Three bids were received and opened on July 20, 2017. Of the three of bids, received two bids were from MBE/WBE certified firms. Muniz Concrete & Contracting, Inc. submitted the lowest responsive bid of three bids received:
