Authorize negotiation and execution of a multi-term contract with Stanley Convergent Security Solutions Inc., to provide an electronic alarm system which includes monitoring, maintenance, and installation services, for up to three years for a total contract amount not to exceed \$855,000. (Note: Sole source contracts are exempt from the City Code Chapter 2-9C Minority Owned and Women Owned Business Enterprise Procurement Program; therefore, no subcontracting goals were established.)

Fiscal Note	Funding in the amount of \$120,000 is available in the Fiscal Year 2017-2018 Operating Budget of Austin Public Health. Funding in the amount of \$120,000 is available in the Fiscal Year 2017-2018 Operating Budget of Parks and Recreation Department. Funding in the amount of \$5,000 is available in the Fiscal Year 2017-2018 Operating Budget of Municipal Court. Funding for the remaining contract term is contingent upon available funding in future budgets. A fiscal note is not required.

Additional Backup Information:

The contract will provide electronic alarm monitoring and equipment maintenance, system installation, and upgrades for the Austin Public Health department, Parks and Recreation department, and Municipal Court. Stanley Convergent Security Solutions Inc. (Stanley) currently owns the electronic monitoring systems located in 127 City facilities and buildings and Stanley does not allow other companies to monitor or support their proprietary systems.

The contract will allow for system installation at current City locations and removal of equipment at locations that are closing. New facilities will only be added to this contract after the Communications and Technology Management department has determined that the facility needs cannot be met under the Enterprise Security Access System program.

The current contract with Stanley expires September 30, 2017 and has an authorized amount of \$1,451,000 with \$1,191,833 in expenditures across six City departments. The new contract will support three City departments through their transition to the new Citywide electronic surveillance contract over the next three years.

If a contract is not secured, City properties will not be provided electronic monitoring until new services are in place. The transition to new systems will take an estimated three years or longer due to the vast amount of City properties requiring these services.
