

**AUSTIN CITY COUNCIL  
MINUTES****SPECIAL CALLED MEETING  
TUESDAY, SEPTEMBER 5, 2017**

The City Council of Austin, Texas convened in a Special Called meeting on Tuesday, September 5, 2017, City Hall, 301 W. Second Street, Austin, Texas.

Mayor Pro Tem Tovo called the meeting to order at 10:23 a.m. Council Member Casar was absent.

2. Authorize negotiation and execution of an interlocal agreement in the form of a mutual aid agreement with the City of Houston to furnish aid in response to an emergency, including in response to a natural event such as Hurricane Harvey.  
**The motion authorizing negotiation and execution of an interlocal agreement in the form of a mutual aid agreement with the City of Houston was approved on Council Member Flannigan's motion, Council Member Houston's second on an 8-0 vote. Mayor Adler and Council Member Pool were off the dais. Council Members Casar was absent.**
3. Authorize negotiation and execution of an interlocal agreement in the form of a mutual aid agreement with the City of Victoria to furnish aid in response to an emergency, including in response to a natural event such as Hurricane Harvey.  
**The motion authorizing negotiation and execution of an interlocal agreement in the form of a mutual aid agreement with the City of Victoria was approved on Council Member Houston's motion, Council Member Alter's second on an 8-0 vote. Mayor Adler and Council Member Pool were off the dais. Council Members Casar was absent.**
4. Discuss and take appropriate action related to the effects of Hurricane Harvey, to include appropriation of staff, funds, supplies and equipment to address emergencies along the Texas gulf coast and the execution of agreements to accomplish the same.  
**This item was withdrawn without objection.**

**Presentation was made by Ed Van Eenoo, Deputy Chief Financial Officer.**

**The following items were discussed:**

- **G-3: Ombudspersons or case managers to assist small and local businesses in the permitting process and to serve as a hub for local businesses to have a single point of contact within DSD.**

**Direction was given to staff to provide information on the impact of funding the additional staff requested by Development Services Department for 7 months in FY18 will have on the FY19 Budget.**

- **S-20: Repurpose partial funding for EMS Service Delivery Model Study (related to S-105); and S-105: Repurpose partial funding for EMS Service Delivery Model Study (related to S-20).**

**Direction was given to staff to list these items as one merged item as well as two separate items and clarify that the reallocation the \$175,000 is to be directed to the Electronic Patient Care Report Solutions for the EMS Department.**

- **E-22: Place Based Planning.**

**Direction was given to staff to change the name to small area planning; to change the amount from \$275,000 to \$100,000; and provide Council with information on the number of existing staff working on small area planning projects.**

- **E-23: Institutional Racism and Systemic Inequities Phase II.**

**Direction was given to staff to delete this item.**

- **E-27: Displacement Task Force**

**Direction was given to staff to change the amount from \$200,000 to \$100,000 of one-time funding.**

**Staff indicated that \$50,000 would be one-time funding and the remaining \$20,000 would come from the General Fund.**

**Direction was given to staff to provide clarification on the ending balances of the reserve funds.**

**Direction was given to staff to delete this item; and to provide Council with an update on how the reallocation of some positions from sworn personnel to non-sworn personnel worked within the Police Department.**

**Direction was given to staff to change the amount from \$778,000 to \$568,000.**

- **Direction was given to staff to schedule an executive session to provide an update on the mediation occurring with the Fire Department contract.**
