PROPERTY MAINTENANCE CODE ORDINANCE

PROPOSED CODE AMENDMENT:	PROPOSED CHANGES WOULD AMEND ARTICLE 9 (PROPERTY MAINTENANCE CODE) OF THE LAND DEVELOPMENT CODE, CODIFY PRE-EXISTING REQUIREMENTS UNDER ARTICLE 11 (RESIDENTIAL CODE) TO THE PROPERTY MAINTENANCE CODE, REORGANIZE AND CLARIFY PREVIOUSLY ADOPTED SECTIONS IN THE PROPERTY MAINTENANCE CODE, ADD SECTION 705 REQUIRING THE INSTALLATION OF CARBON MONOXIDE ALARMS IN ALL SLEEPING AREAS, AS WELL AS THE REQUIREMENT TO HAVE VISIBLE ADDRESSES ON ALL RESIDENCES.

IMPACT ON COST OF DEVELOPMENT	PROPOSED CHANGES WOULD MARGINALLY INCREASE COSTS TO DEVELOPER OR OWNER. ADDRESSING = \$6.18, CARBON MONOXIDE ALARM = \$35.95 PER ALARM. SINCE THE COSTS ARE MARGINAL AND CARBON MONOXIDE ALARMS ARE REQUIRED TO ENSURE RESIDENTIAL SAFETY, NEIGHBORHOOD HOUSING CONSIDERS THEM REASONABLY ACCEPTABLE COSTS.
