## HISTORIC LANDMARK COMMISSION OCTOBER 23, 2017 DEMOLITION AND RELOCATION PERMITS HDP-2017-0515 2007 RIVERVIEW STREET

# PROPOSAL

Demolish a ca. 1937 house.

# ARCHITECTURE

One-story, rectangular-plan, side-gabled frame house with a central, partial-width, front-gabled independent porch on plain square wood posts; single 1:1 fenestration.

## RESEARCH

City records indicate a construction date of 1937 for this house. Until around 1946, the house was occupied by a series of renters, including two laborers and their families, and an auto mechanic. Around 1946, the house was purchased by Willard L. and Annie Mae Hays, who lived here until around 1972. Willard Hays was a laborer and driver for a feed mill. Since 1972, the house has largely been a rental property with a series of short-term renters.

## STAFF COMMENTS


The East Austin Historic Resources Survey (2016) notes that the doors, windows, and exterior wall materials have been replaced, and that the porch has been altered. The survey recommends that the house is not eligible for designation as a local landmark nor as contributing to a potential historic district.

The house does not meet the criteria for landmark designation as set forth in City Code:

- a. **Architecture.** The house is a frame 1930s house with many original materials replaced. The house has no distinction within its architectural style.
- b. **Historical association**. The owners with the most significant association with this house, Willard and Annie Mae Hays, do not appear to meet the criterion for significant historical associations.
- c. **Archaeology**. The house was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
- d. **Community value**. The house does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.
- e. Landscape feature. The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

## STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, then relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center. The house does not meet the criteria for individual designation as a historic landmark.

## Willard L. and Anne M. Hays (ca. 1946 - ca. 1972)


The 1940 U.S. Census shows Willard and Anna May Hays living in the home of Willard's parents, James and Eva J. Hays, at 646 Northwestern Avenue. Willard Hays was 30, had been born in Texas, and was a feed mixer at a feed mill. Anna May Hays was 20, had been born in Texas, and had no occupation listed. They had a son, J.W., 2 months. Willard's father had no occupation listed in the census report, but his mother was a seamstress in a sewing room. Willard's oldest brother, Ted, 31, was also a feed mixer at a feed mill.

Annie Mae Hays died in 1969 and is buried in Liberty Hill, Texas. Willard Hays died in Ashmore, Coles County, Illinois, in 1985, and was also buried in Liberty Hill. He does not seem to have had an obituary in the Austin newspapers.
