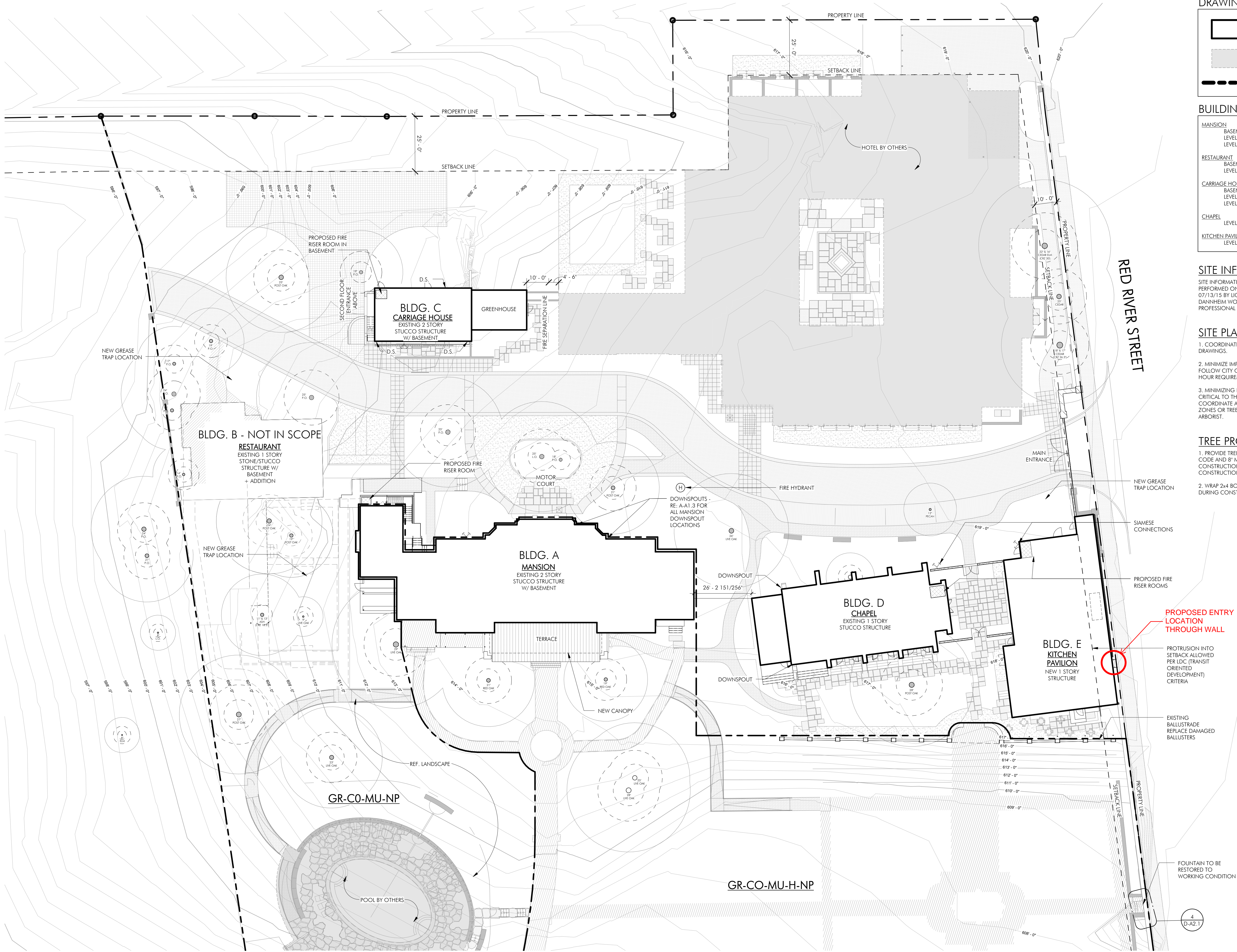

SITE PLAN NOTES:

- COORDINATE LAYOUT WITH CIVIL AND LANDSCAPE DRAWINGS.
- MINIMIZE IMPACT/DISTURBANCE OF NEIGHBORS; FOLLOW CITY OF AUSTIN CONSTRUCTION WORK HOUR REQUIREMENTS.
- MINIMIZING IMPACTS TO EXISTING TREES IS CRITICAL TO THE SUCCESS OF THIS PROJECT. COORDINATE ALL DISTURBANCES IN CRITICAL ROOT ZONES OR TREE CANOPY PRUNING WITH OWNER'S ARBORIST.

TREE PROTECTION NOTES:

- PROVIDE TREE PROTECTION FENCING PER CODE AND 8" MULCH GROUND COVER DURING CONSTRUCTION AROUND ALL TREES IN THE CONSTRUCTION AREA.
- WRAP 2x4 BOARDS AROUND TREE TRUNKS DURING CONSTRUCTION.

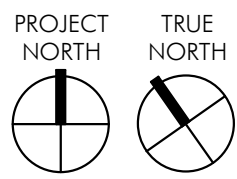
