b) Authorize negotiation and execution of a professional services agreement with AECOM Technical Services, Inc., (staff recommendation) for Request for Qualifications Solicitation No. CLMP231A to provide consulting services for the Austin-Bergstrom International Airport Terminal Centralized Baggage Handling System Design Criteria Manual in amount not to exceed \$700,000.

d) Authorize award, negotiation, and execution of a concession agreement with ABIA Duty Free, LLC and its joint venturers (ABIA Duty Free) or one of the other qualified offerors to the Request for Proposals for Terminal Concessions (RFP-8100-ABIA-004), to lease, design, construct, and maintain a food, beverage, and retail concession at Austin-Bergstrom International Airport for a term not to exceed ten years.

e) Authorize award, negotiation, and execution of a concession agreement with Delaware North Companies Travel Hospitality Services, Inc. and its joint venturers (DNC), or one of the other qualified offerors to the Request for Proposals for Terminal Concessions (RFP-8100-ABIA-004), to lease, design, construct, and maintain a food, beverage, and retail concession at Austin-Bergstrom International Airport for a term not to exceed ten years.

Motion passed 9-0-0-2 (With Commissioners John Walewski and Mike Rodriguez absent at this vote). g) Authorize award, negotiation, and execution of a concession agreement with InMotion Entertainment Group, LLC and its joint venturers (InMotion) or one of the other qualified offerors to the Request for Proposals for Terminal Concessions (RFP-8100-ABIA-004), to lease, design, construct, and maintain a food, beverage, and retail concession at Austin-Bergstrom International Airport for a term not to exceed ten years.

i) Authorize award, negotiation, and execution of a concession agreement with Prevost Consulting Group, LLC and its joint venturers (Prevost) or one of the other qualified offerors to the Request for Proposals for Terminal Concessions (RFP-8100-ABIA-004), to lease, design, construct, and maintain a food, beverage, and retail concession at Austin-Bergstrom International Airport for a term not to exceed ten years.

j) Authorize award, negotiation, and execution of a concession agreement with Vino Volo Texas, LLC and its joint venturers (Vino Volo) or one of the other qualified offerors to the Request for Proposals for Terminal Concessions (RFP-8100-ABIA-004), to lease, design, construct, and maintain a food, beverage, and retail concession at Austin-Bergstrom International Airport for a term not to exceed ten years.

Motion to approve. Motion made by Frank Maldonado and seconded by Jeremy Hendricks. Motion passed 7-0-2-2 (With Commission Members John Walewski and Mike Rodriguez absent at this vote, Commission Members Michael Watry and Ernest Saulmon abstained from voting on this item). The Airport Advisory Commission recommends the negotiation and execution of a concession agreement with other qualified offeror Knot Anymore, LLC to the Request for Proposals for Terminal Concessions (RFP-8100-ABIA-004), to lease, design, construct, operate, and maintain a food, beverage, and retail concession at Austin-Bergstrom International Airport for a term not to exceed ten years.

Authorize the use of the competitive sealed proposal procurement method for solicitation of the new construction of the Consolidated Maintenance Facility for the Aviation Department located at Austin-Bergstrom International Airport. 

Tenant Updates and Business Development Events

- 1. On November 7th, Air Canada's announced its decision to increase capacity, by serving its route with a larger Embraer EMB 190 aircraft, on its daily nonstop flights to Toronto's Pearson International Airport (YYZ). Beginning May 1, 2018, the upgraded service will provide 21 more seats per flight between Austin and Toronto. The larger Air Canada aircraft will feature nine Business Class seats and 88 main cabin seats.
- 2. On November 10th, the Airport's east food court, excluding Auntie Anne's, close as part of a complete renovation to be undertaken by Delaware North Companies. Upon completion, the renovated food court will feature Peach Tortilla, Juice Land, and a Live Oak inspired bar.
- 3. On November 15th, Austin-Bergstrom International Airport welcomed ViaAir's announcement of new nonstop service from Austin-Bergstrom International Airport (AUS) to Oklahoma City, Oklahoma (OKC) and to Tucson, Arizona (TUS), beginning January 18, 2018. ViaAir plans to base crews and maintenance at the Austin-Bergstrom International Airport, positioning its Austin based operations to expand.
