## **ORDINANCE NO.**

AN ORDINANCE AMENDING CITY CODE CHAPTER 13-2 (GROUND TRANSPORTATION PASSENGER SERVICES) RELATED TO CHAUFFEUR PERMITS, LIMOUSINE SERVICE, TRANSPORTATION NETWORK COMMPANY SERVICE, AND CHARTER BUS SERVICE.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

- **PART 1.** Section 13-2-1 (*Definitions*) of City Code Chapter 13-2 (*Ground Transportation Passenger Services*) is amended to read:
  - (28) PREARRANGED SERVICE means ground transportation service provided by a ground transportation service operating authority that is scheduled by [an initial] reservation [a minimum of one-half hour] in advance of the trip, excluding performance under a corporate contract or by a Charter Bus Service.
- **PART 2.** City Code Section 13-2-103 Subsection (A) (*Disqualification for Certain Offenses*) is amended to read:
  - (A) Except as provided in subsection (D), applicants for a chauffeur's permit or for a renewal are disqualified if, within the seven years preceding the date of the application, the applicant has been convicted under the laws of this state, or of any other U.S. state or territory, or of the United States, of the offense or offenses of:
    - (1) a felony not listed in subsection (B) of this section;
    - (2) the misdemeanor <u>possession</u>, sale, manufacture, or delivery of a controlled substance or chemical precursor;
    - (3) driving, flying, or boating while intoxicated or under the influence;
    - (4) prostitution or solicitation of a lewd act;
    - (5) fraud or forgery;
    - (6) resisting or evading arrest or detention;
    - (7) reckless driving or obstructing a highway or other passageway;
    - (8) [any crime involving arson] criminal mischief[,] or other property damage or destruction;

59 60	<b>PART 4.</b> City Code Chapter 13-2 ( <i>Ground Transportation Passenger Services</i> ) Section 13-2-121 ( <i>Exception from Chauffeur's Permit Requirement</i> ) is repealed.
61 62 63	<b>PART 5</b> . Subsections (B) and (D) of City Code Section 13-2-202 ( <i>Limousine Service Requirements</i> ) are repealed, and Subsection C is renumbered and repealed and replaced to read as follows:
(B)[(C)] A holder may provide limousine service using a full-sized service vehicle categorized as a luxury vehicle within the automobile industry, with a minimum occupancy capacity of four passengers excluding the driver, or a vehicle categorized the automobile industry as a sport utility vehicle with a minimum occupancy capacity of four passengers excluding the driver.	
70 71 72	<b>PART 6.</b> City Code Section 13-2-203 ( <i>Limousine Minimum Rate of Fare</i> ) is repealed and City Code Section 13-2-204 ( <i>Trip Ticket Required</i> ) is renumbered as Section 13-2-203.
73 74	<b>PART 7.</b> City Code Section 13-2-267 ( <i>Vehicle to Display Permit</i> ) is repealed and the subsequent sections are renumbered accordingly.
75 76	<b>PART 8.</b> City Code Section 13-2-286 ( <i>Special Event Permit Application</i> ) Subsection (D) is repealed and Subsections (E) through (G) are relettered accordingly.
77 78	<b>PART 9.</b> City Code Section 13-2-291 ( <i>Charter Van Service Requirements</i> ) Subsection (B) is amended to read:
79	A holder must:
80 81	(1) use vans, minibuses, buses, or motor coaches that comply with the following requirements to provide charter van service:
82 83	(a) have an occupancy capacity of fifteen persons or less, including the driver;
84	(b) have no top light or other electric identification sign;
85	(c) not use a taximeter;
86 87	(d) no checkered logo/pattern or insignia to represent the vehicle as a taxicab;
88 89	(e) if a charter van service holder identifies its vehicles with outer logos or other identification markings, all vehicles used to provide

90 91	charter services owned by the same holder shall have identical markings on all vehicles that are unique to that holder.
92 93 94 95	(2) provide the department with a current list of drivers licensed in the manner described in <u>Section 13-2-121</u> ( <i>Exemption from Chauffeur's Permit Requirement</i> ), the driver's license number of each driver, and a photocopy of each driver's license.
96 97 98	(3) provide the department with a copy of proof of a passing annual vehicle inspection conducted by the City or the designated inspector authorized by the City to conduct inspections.
99 100 101	(4) not hold itself out as a taxi service as defined in <u>Section 13-2-401</u> ( <i>Taxi Service Described</i> ) [, and cannot accept passengers less than one-half hour in advance of commencement of scheduled service].
102 103 104 105 106 107	(5) A driver operating a charter van service vehicle shall keep in the vehicle, in written or electronic form, a trip ticket containing the information described below, and shall allow a person designated under <u>Section 13-2-13(B)</u> ( <i>Enforcement</i> ) or <u>Section 13-2-14</u> ( <i>Enforcement Officers</i> ) to inspect the trip ticket upon request. A trip ticket must include the following information:
108 109	(a) date of the trip, the name, address, and phone number of the person or group who booked or paid for the service;
110 111	(b) the name, address, and phone number of at least one passenger transported on the trip;
112 113	(c) the pickup location, intermittent stops and the drop off location for the trip;
114 115	(d) the date and time the reservation was made, and the scheduled and actual passenger pick-up time;
116 117 118	(e) state the rate for services, if charged on an hourly rate, and total amount of fare paid for each passenger or group of passengers using the service; and
119 120 121	(f) identify the owner of the vehicle used to provide charter service and identify the holder, if different, by name, address and telephone number.
