


- Restoring the sense of procession through the site




"This area of the grounds will be considered here as a representative example of the way in which Driscoll often combined icons of the Old World and Texas in her Gardens... "These great gates have particular appeal to me because I rescued them from the caverns of the state capitol. They once adorned the entrances to our capitol grounds and as you would observe, they bear the official crest of the state of Texas and their points are the beloved single star that signifies Texas."

- Clara Driscoll purchased (2) sets of gates from the Texas State Capitol grounds for relocation to Laguna Gloria as early as 1925
- The original 35th St. entry gates were removed, whereabouts unknown
- Current 35th Street gates were originally located at the Temple of Love
- The gates were modified from their original shape and width to incorporate (2) pedestrian gates on each side in the 1980s






1998 CURRENT FRONT GATES FORMERLY AT END OF PATH TO THE POINT


1968 ORIGINAL FRONT GATES


Entry Sequence and Procession - Per Cultural Landscape Report











"Historic documentation has shown that the procession or sequence of movement throughout Clara Driscoll's garden was an important element within the overall design of the landscape... Historically, there were two primary routes for entering the site. The first was through the front entrance gates, around the Oval Drive, through the Arch and Balustrade at the Northeast corner of the House and into the garden spaces on the north and west sides of the House...."

Recommended Action - Approved by HLC


- "The overall layout of the main entrance at 35th St. has changed significantly since the historic period. The walls have been reconfigured to accommodate a cul-de-sac turn-around with sidewalks."
- "It is recommended that the gates that are currently located at the front entrance be returned to their historic location at the end of the Path to the Point."
- "It is recommended that the historic gates be refabricated and reinstalled."






EXISTING GATE AT 35TH STREET W/ PEDESTRIAN LEAVES ADDED




Gatehouse Evolution - Per Historic Structure Report by Hardy Heck Moore & Myers (2000)

The "Gatehouse" is a utilitarian, one-story, masonry and wood building constructed on a series of concrete and stone foundations. The hip-roofed structure was constructed in three distinct building phases, each phase reflecting the buildings changing use. Located southeast of the entry gate, the Gatehouse is set apart from the Driscoll Villa and its formal grounds.

The original building, built somewhere between 1916 and 1925, has been modified on three different occasions (most recently as of 2008) leading to a structure which has lost much if not all of its historic significance. These modifications have altered the interiors and exteriors to a large degree and have changed the original building drastically, both formally and programmatically. Currently, the building houses a small art gallery, IT room, ADA restroom, storage closet, and the Education and Art School administrative offices.

"These modifications have substantially altered the original appearance of the Gatehouse and diminish its ability to communicate relevant significance. The Gatehouse is believed to be a noncontributing feature to the Laguna Gloria National Register District."









Gatehouse Floor Plan - current



Gatehouse Floor Plan - proposed








Arrival Garden Plan - proposed




NORTH ELEVATION (LOOKING FROM CUL-DE-SAC)




WEST ELEVATION (LOOKING FROM OVAL)


