Motion to approve the proposed 2018 schedule was made by Commissioner Pitts and seconded by Commissioner Yeatts. The motion passed on a 8-0 vote.

c. Discuss the GTOPs 2018 Grant Review Panel applications, and vote to appoint the final panel (Jesse Rodriguez, Business Process Specialist)

The commission voted for applicants 2B, 3C, 4D, 5E, 9I, 10j, and 13M to serve on the panel. The Digital Inclusion Office proposed the selected panel for approval to the commission.

Motion to appoint applicants 2B, 3C, 4D, 5E, 9I, 10j, and 13M to serve on the GTOPs 2018 grant review panel was made by Commissioner DasGupta and seconded by Commissioner Syed. The motion passed on a 8-0 vote.

Commissioner Pitts noted that the working group has set its first meeting for the group.

b. Knowledge, Information, and Data Stewardship Working Group.

The presentation by Stephen Elkins has addressed the usability of city websites, security, and inter-departmental use of technology.

Commissioner Pitts is working with the City auditor on usability of online services.

- Goal 3: Commissioner DasGupta has been in contact with Paul Lewis on control of the City's right of way and the impact of the state legislation.
