

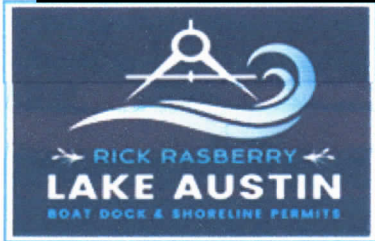

Dear Mr. Rasberry,

This email is in response to your request for information regarding:

1611-1887 Westlake Dr.

On behalf of the City of Austin's Development Services Department (DSD), there were 116 permits found for the above listed property addresses. Inspection reports are listed on the back of these permits. The estimated cost for time in retrieving, compiling, copying and redacting information from these records is **\$104.40**.

Narrowing the scope of the request might reduce the estimated cost. There also might be a less expensive way for you inspect this information without receiving a copy. You may contact our office to discuss those less costly alternatives.

Pursuant to section 552.2615 of the Government Code, your request will be considered automatically withdrawn if you do not notify us in writing within **10 business days** from the date of this statement that you:

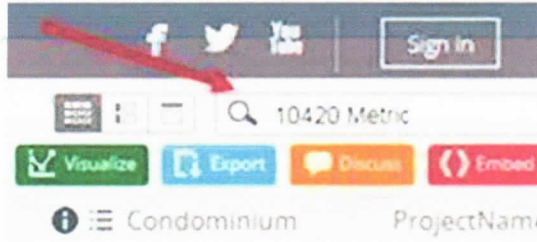
- a. Accept the charges and agree to pay;
- b. Right to inspect;
- b. Modify your request; or
- c. Have sent to the Cost Rules Administrator at the Office of the Attorney General a complaint alleging that you have been overcharged for being provided with a copy of the public information.

1. Go to <https://data.austintexas.gov/Permitting/Issued-Construction-Permits/3syk-w9eu/data>
2. Type in address (**tip** – do not include Boulevard, Street, or Highway, etc. These names could be listed as an abbreviation such as Blvd, ST, and HWY thus limiting results)



3. Click enter and you're done!

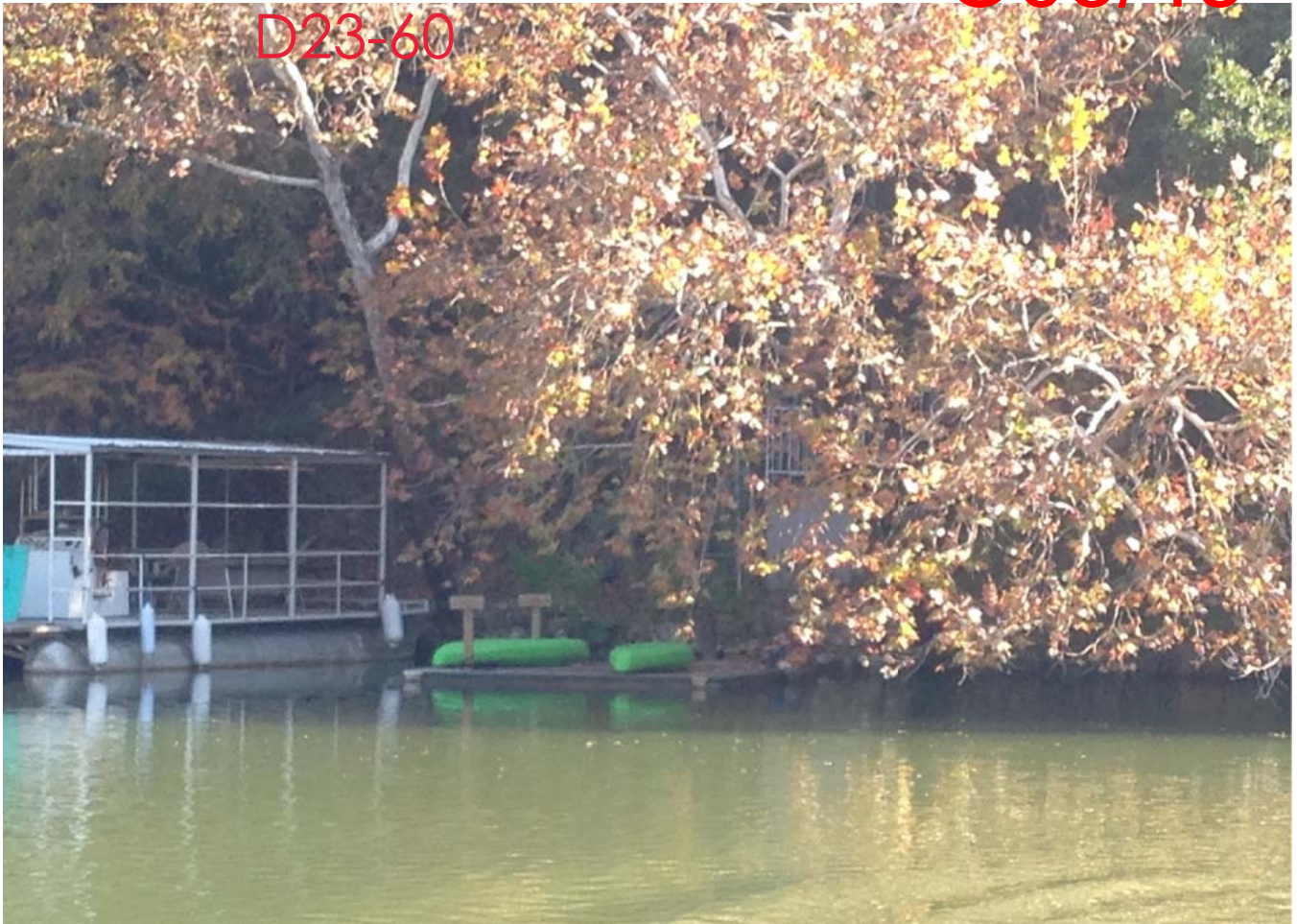

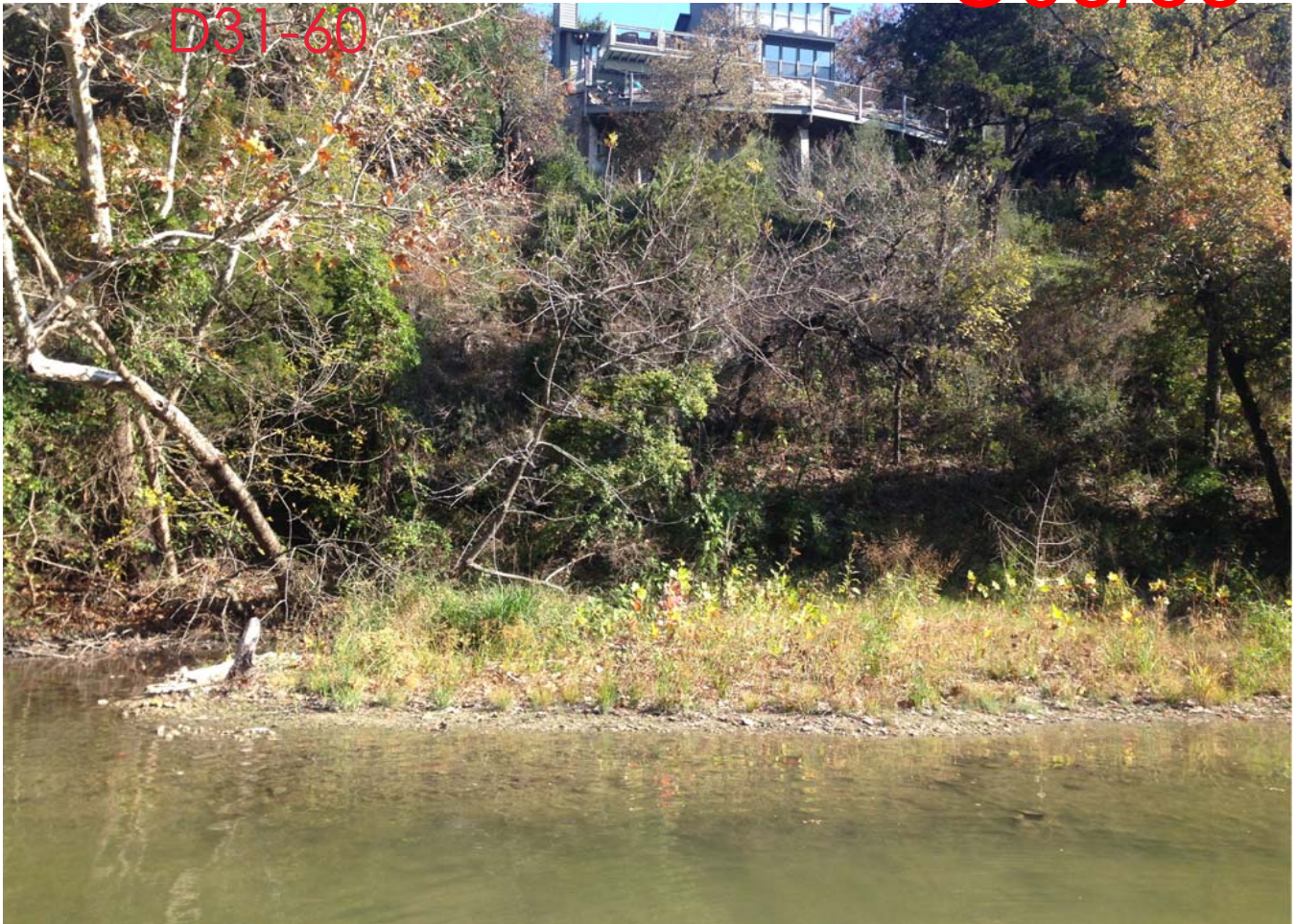
